Legal Notice of Decision for the Dry Burton Thin Timber Sale Gifford Pinchot National Forest, Cowlitz Valley Ranger District

Kristie Miller, District Ranger for the Cowlitz Valley Ranger District, made the decision to implement the Dry Burton Thin Timber Sale, selecting Alternative 4.1 on July 31, 2006. With this current decision, the District Ranger is rescinding the July 31, 2006 decision to select Alternative 4.1, and selecting Alternative 4, the original Proposed Action. This alternative was selected from a range of alternatives analyzed in the Environmental Assessment (EA) prepared for the proposal. Alternative 4 is identical to Alternative 4.1, except that Units 5, 6 and 8 would contain a mixture of ground-based and helicopter yarding systems. Units 4 and 17 would still be entirely helicopter harvested. The change was made because market conditions have reduced the value of the sale, resulting in a negative cost benefit ratio and net cost to the government. Alternative 4 was analyzed in detail in the EA and in supporting documentation. The selected alternative will commercially thin and harvest approximately 4.2 million board feet of timber from 212 acres of the Cispus Valley Adaptive Management Area, and Upper Cowlitz River Watershed. The purposes of the project are to increase the health and vigor of managed stands while promoting the structural elements of late successional forest land, to provide forest products consistent with the Northwest Forest Plan, and to enhance riparian reserves. The project is located approximately 6 miles south of Packwood in Sections 15, 21, 22, 27 and 28, T 12 N, R 9 E, Willamette Meridian, Lewis County, Washington.

These alternate formats are available upon request at the address listed above. The EA for this project was available for a 30 day public comment period from June 20 to July 20, 2006. This decision is subject to administrative review (appeal) pursuant to 36 CFR Part 215 (revised, June 2004). Appeals must meet the content requirements of 36 CFR 215.14. Only individuals or organizations who submitted comments or otherwise expressed interest in the project during the comment period may appeal. Appeals, including attachments, must be filed within 45 days from the publication date of this notice in *The Chronicle*, the newspaper of record. Incorporation of documents by reference is not allowed. Attachments received after the 45 day appeal period will not be considered. The publication date in *The Chronicle*, newspaper of record, is the exclusive means for calculating the time to file an appeal. Those wishing to appeal this decision should not rely upon dates or timeframe information provided by any other source.

The Appeal Deciding Officer is Claire Lavendel, Gifford Pinchot Forest Supervisor. The office business hours for those submitting hand-delivered appeals are 8:00 AM to 4:30 PM Monday through Friday, excluding holidays. Electronic appeals must be submitted in a format such as an email message, plain text (.txt), rich text format (.rtf), Word (.doc) or portable document format (.pdf). In cases where no identifiable name is attached to an electronic message, a verification of identity will be required. A scanned signature is one way to provide verification. E-mails submitted to email addresses other than the one listed above, or in formats other than those listed or containing viruses, will be rejected. It is the responsibility of the appellant to confirm receipt of appeals submitted by electronic mail.

If no appeals are received, this decision may be implemented no sooner than five days following the close of the appeal period. If an appeal is received, implementation may begin 15 days following the disposition of all appeals.
