ORDER NO. 06-03-03-08-01

SPECIAL AREA CLOSURE

Pursuant to 36 CFR 261.50(a), the following acts are prohibited on the area described in this order and depicted on Exhibit A, within and/or administered by the Gifford Pinchot National Forest, Mount Adams Ranger District, until further notice:

1. Going into or being upon the area affected by the Cold Springs Fire. (36 CFR 261.52(e))

AREA DESCRIPTION:

The following description serves as the exterior boundary and closes all lands encompassed within it and as depicted in the unshaded area depicted in attached Exhibit A:

From a point of beginning, E of the intersection of National Forest System (NFS) Road 2300 (posted 23) with the south boundary of the Gifford Pinchot National Forest (GPNF), in the SE corner of Section 33, T7N, R10E, then E about 5 ¼ miles along the south boundary of the GPNF to the SE corner of Section 32, T7N, R11E, then N about a half-mile along the E section line of Section 32, T7N, R11E then again E through the middle of Section 33 of T7N, R11E to its E section line then N along the E boundary of the GPNF to the 12,200' level of Mount Adams in Section 12, T8N, R10E, travel that elevation NW about ½ mile to The Pinnacle, then SW about 3 ½ miles along the W slope of Mount Adams to the intersection of Round-the-Mountain Trail #9 with Pacific Crest Trail #2000, then travel westerly about 6 miles along the S side of Trail #2000 to its intersection with NFS Road 23 near NFS Road 8810, then S along the E side of NFS Road 2300 about 9 ½ miles to the point of beginning.

Pursuant to 36 CFR 261.50 (e), the following persons are exempt from this Order:

- (1) Persons with a permit specifically authorizing the prohibited act or omission.
- (2) Any Federal, State, or local law enforcement officer or a member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.
