## **MANDATORY EXAM OPTIONS**

DOE regulations require that **OMC must perform this physical examination** (see Federal Regulation 10CFR851 *Worker Safety and Health Program*, Appendix A, Section 8 *Occupational Medicine*). OMC physicians and practitioners have a knowledge of your job and have training and expertise in health issues related to work.

When an employee has a mandatory physical examination at OMC (mandated by DOE or OSHA requirements) the employee has the following 2 choices:

Choice #1: accepting a full physical exam and testing; or

Choice #2: notifying OMC that you would like the minimum examination and testing

necessary to satisfy the mandatory medical surveillance or certification

requirements.

<u>Choice #1</u>: The OMC physician or nurse practitioner and clinical staff will perform a complete physical examination, routine OMC tests and lab work, as well as any additional blood work or tests needed to complete this protocol. See FAQ #3 for a list of routine OMC tests and bloodwork.

<u>Choice #2</u>: The OMC physician or nurse practitioner and clinical staff will perform the minimal physical exam and testing necessary to complete your mandatory medical surveillance or certifications. See the table below for a list of your mandatory surveillance or certification and the range of exams and tests typically needed to complete them.

 Note that, at the discretion of the examining physician or nurse practitioner, additional tests may be needed in addition to those listed in the table below as the typical minimum.
