A BILL FOR AN ACT

RELATING TO THE HAWAII NATIONAL GUARD.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. This Act is recommended by the governor for
2 immediate passage in accordance with section 9 of article VII of
3 the Constitution of the State of Hawaii.

4 SECTION 2. The purpose of this Act is to increase the
5 authorization of the department of defense to expend
6 interdepartmentally transferred funds for the Operation About
7 Face program by increasing the amount for fiscal year 2006-2007
8 from \$4,700,000 to \$7,900,000 in item I-20 of section 3 of Act
9 178, Session Laws of Hawaii 2005, as amended by Act 160, Session
10 Laws of Hawaii 2006.

11 The authorization to expend additional interdepartmentally
12 transferred funds will allow the department of defense to
13 receive and expend all the federal temporary assistance to needy
14 families funds received from the department of human services
15 for the Hawaii national guard's Operation About Face family of
16 programs statewide.



1 SECTION 3. Act 178, Session Laws of Hawaii 2005, as
2 amended by Act 160, Session Laws of Hawaii 2006, is amended by
3 amending item I-20 of section 3 to read as follows:


