# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to departmental  
4 administration and budget division (BUF 101) the following sums  
5 or so much thereof as may be necessary to fund for fiscal  
6 biennium 2007-2009 all collective bargaining cost items in the  
7 agreement negotiated with the exclusive bargaining  
8 representative of collective bargaining unit (5):

14 SECTION 2. Funds appropriated or authorized by this part  
15 shall be allotted by the director of finance to the appropriate  
16 state departments for expenditure in the respective fiscal year  
17 for the purposes of this part.

2 SECTION 3. There are appropriated or authorized from the  
3 sources of funding indicated below to departmental  
4 administration and budget division (BUF 101) the following sums  
5 or so much thereof as may be necessary to fund for fiscal  
6 biennium 2007-2009 the salary increases and other cost  
7 adjustments authorized by chapter 89C, Hawaii Revised Statutes,  
8 for state officers and employees excluded from collective  
9 bargaining who belong to the same compensation plans as those  
10 officers and employees within bargaining unit (5):

14 SECTION 4. Funds appropriated or authorized by this part

19 SECTION 5. There are appropriated or authorized from the  
20 source of funding indicated below to departmental administration  
21 and budget division (BUF 101) the following sums or so much

1 thereof as may be necessary to fund for fiscal biennium 2007-  
2 2009 the voluntary employee benefit association costs in the  
3 agreement negotiated with the exclusive bargaining  
4 representative of collective bargaining unit (5):

7        SECTION 6. Funds appropriated or authorized by this part  
8 shall be allotted by the director of finance to the appropriate  
9 state departments for expenditure in the respective fiscal year  
10 for the purposes of this part.

12        SECTION 7. Salary increases and cost adjustments provided  
13 in this Act for any officer or employee whose compensation is  
14 paid, in whole or in part, from federal, special, or other funds  
15 shall be paid wholly or proportionately, as the case may be,  
16 from the respective funds.

17        SECTION 8. Funds appropriated or authorized by this Act  
18 that are not expended or encumbered by June 30, 2008, and  
19 June 30, 2009, of the respective fiscal years, shall lapse as of  
20 those dates.

21        SECTION 9. This Act shall take effect on July 1, 2007.
