In September, the draft plan for securing affordable quality health care for every Oregonian will be ready for *your* review.

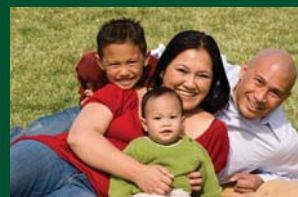
Plan to attend one of 10 community town hall forums across the state to hear details, ask questions and give feedback before the plan is finalized. Your participation is important in this vital effort.
