2007 Oregon Legislative Assembly

The 74th Oregon Legislative Assembly adjourned Thursday, June 29th, 2007. Health care was a prominent topic this session.

Of note, Oregonians will vote on Senate Joint Resolution 4 (SJR 4) on the November 2007 ballot. If approved by the voters, SJR 4 will increase the tobacco tax to implement Healthy Kids, a program to provide universal health care for children, and revenue permitting, provide care for low-income adults and other medically underserved Oregonians.

Additionally, several key bills passed that are supported by the OHPC *Road Map for Health Care Reform.* The Healthy Oregon Act (SB 329) provides a detailed timeline for developing a full-scale reform plan for Oregon. The bill creates the Oregon Health Fund Board to design a comprehensive reform plan with the assistance of five subcommittees. SB 329 builds on much of the reform work accomplished to date by using existing state commissions, including the OHPC, as the backbone of the subcommittees.

No Q & T Workgroup meeting in July or August

Additional milestones in improving health care quality and transparency were achieved with the passage of HB 2524 and HB 3290. HB 2524 takes effect this month and allows OHPR to establish the Oregon Health Care Acquired Infection Reporting Program. HB 3290 requires OHPR to establish a community benefits reporting system for hospitals (effective January 2008).

During the session, Oregon Legislators showed their commitment to improving public health, especially for children. HB 2650 outlining nutritional standards in schools passed (effective July 2007), bringing us one step closer to better health for children and our community.

What's New

SB 329 Health Fund Board

Barney Speight was appointed Executive Director of the Health Fund Board and will start August 1st. The Governor's Office will start recruiting board members in August for legislative confirmation in September. An overview of SB 329 can be found on the OHPR website under "What's New".

OHPC Road Map for Health Care Reform published in final

The OHPC released its draft reform report in March of 2007. The report was open for public comment throughout the spring and was used as a reference during the development of SB 329. Several of the Commission's recommendations are included in SB 329, including the development of a health insurance exchange and a quality institute.
