Road Map to Health Reform in Oregon

The Commission has dedicated the last year to developing a strategic plan to create a high-value, affordable health system in Oregon.

#### Cooperation and Common Data

## Childhood Obesity Study Report

Following the public comment period which ended on November15, DHS and Commission staff are reviewing public comment and finalizing the report prior to its release at the beginning of the legislative session in January. The report was assembled by a multi-disciplinary team of local and national experts to lay out a comprehensive plan for combating childhood obesity in Oregon, including recommendations for action at all levels. The study is a meta-analysis chaired by Dr. Mel Kohn, State Epidemiologist with the Oregon Department of Human Services in partnership with the Oregon Health Policy Commission.

## 2<sup>nd</sup> Annual Web Release of Oregon Hospital Quality Indicators

The availability of health care quality measures becomes increasingly important as health care costs continue to rise and purchasers and consumers want to understand what they are getting for their health care dollar. The Office for Oregon Health Policy & Research has developed an online resource for the public to access some of this information; it released the new 2005 data on October 30.

The web site provides quality measures for selected health care procedures and conditions performed in hospitals statewide. These measures were developed in collaboration with a work group of hospital representatives and other interested stakeholders and are being made available with the intent of promoting health care and quality outcomes for all Oregonians. The project is part of an extensive evidence-based process under development nationally by the federal Agency for Health Care Research and Quality.
