B. HB 3290: Community benefit reporting, Exhibit D

- Requires new level of annual financial reporting on “community benefit” by Oregon hospitals (the cost of services “intended to address known community health needs”) including losses related to publicly-funded programs, e.g. State Child Health Insurance Program (SCHIP), charity care, community health improvement services, research, in-kind contributions and community-building activities. Costs will be reported per category, not per service, for each reporting organization.

Discussion

- Suggested changes: the definition of “research” needs to be clarified.
- The Office for Oregon Health Policy and Research (OHPR) will decide (by administrative rule) how to design the report and display the data, including a more precise definition of “community benefit”.
- A motion is made that the OHPC express support for HB 3290; there is unanimous consent.

II. Reform and Legislative Updates

Sen. Westlund

A. Health reform legislation

- Appears Healthy Kids Plan likely to require a ballot measure; despite polling which shows a majority of Oregonians, including smokers, supporting a tobacco tax for children's health care coverage, there is likely not enough votes to pass it outright in the Legislature.
- SB 329-A is in Ways and Means Committee awaiting its fiscal impact statement. There appears to be bi-cameral support for the measure.

Discussion

- There appears to be a lot of overlap between the statutory charter of the Oregon Health Policy Commission and the charge to the proposed Health Trust Board. Should SB 329-A pass, the Trust Board will be a temporary body and will expire at the end of 2008 once it has fulfilled its assignment. At that time, the fate of the Trust Board and of the OHPC will

B. Legislative Update

- Water fluoridation (HB 3099) initially had the votes to pass the House upon its third reading last week, but last minute lobbying resulted in enough lost votes that it was referred to the Ways and Means Committee to save it from failing on the House floor.
- HB 3097 has combined medical home, 100% access, rural health clinics/safetynet support and primary care home pilot bills into a single bill that appears to have a good chance of passing out of Ways and Means (20 community grants of \$75,000 each for delivery system model pilot projects)

II. Legislative debrief – overview of health legislation passed

- SB 3C/SJR 4D – Healthy Kids Bills: Revenues from increased tobacco tax will be dedicated to implement SB 3C if voters approve SJR 4D in Nov. 2007 election.
- SB 329 – The Healthy Oregon Act: Major health reform bill. Also, includes health insurance exchange, quality institute model, and information transparency.
- HB 2213, HB 2524, HB 3290, SB 163, SB 362, SB 426, SJR 20, and SB 36: Passed bills related to delivery system reform.
- HB 2650: Outlines nutritional standards in schools, passed except the fluoride bill.

Discussions

- Overall the Commission accomplished a lot through the 2007 legislative session.
- February 2008 Session: Will likely last the 4 weeks of February. A screening process will likely be established to identify and prioritize significant issues on which the legislature will focus. Revenue forecast will be included in the agenda.

III. SB 329 Overview

- Barney Speight was appointed Executive Director of the Health Fund Board and will start on August 1st. The Governor's Office will start recruiting the board members. Once the Director is on board, it will be easier for OHPC to figure out resources and priorities. To implement SB 329, much time and work from OHPH will be demanded.
- **Timeline and SB 329 overview (Exhibit D and E):**
 - a. OHPC will be involved in the Financing Subcommittee.
 - b. The Quality and Transparency Workgroup will be involved in SB 329 work.
 - c. OHPC might be asked to advise or support the Delivery System Subcommittee; however, the direction on subcommittee's work has not been clear.
 - d. All the subcommittees' work and the interim status report on Health Insurance Exchange plan are due by February, 2008.
 - e. Delivery system planning and implementation will be high priorities.

Discussion

- Fund allocation: Gretchen will keep the members informed on how the \$1.8 million dollars appropriated (from now through Oct. 2008) will be used.
- Roles and responsibilities (OHPC vs. Health Fund Board): Section 8 of the bill covers the general description on board members, and Section 9 covers aspects of the OHPC's involvement. Statutory authority of the board and commission in making and approving changes in the health system should be clarified.
- Staff time and resources: OHPH staff members will be very involved in implementing SB 329 and expect to continue participating in the Coordination Group work.
- Suggestion: Important for staff to put together initial funding options (including mechanisms, formulae, finance structure, eligibility, and more) in a work plan for next steps.
- February 2008 session: Funding discussion and some actions on Health Insurance Exchange plan could take place.
- Three-Phase approach to set the stage for next steps:
 - a. Phase I: Staff put together a work plan.
 - b. Phase II: At the August Commission meeting, discuss with the Health Fund Board Director on: (1) board members, (2) OHPC's role in contributing to SB329 implementation; (3) the board Director's perspective on OHPC; (4) Health Exchange and quality health issue; and (5) finance.
 - c. Phase III: Figure out available time, resources, and deliverables.

III. SB 329 Planning

- **Barney gave an update on SB 329 implementation:**
 - Fully constituted Oregon Health Fund Board will be in place next month (Sep. 2007). At least 5 subcommittees will simultaneously work in various areas.
 - The OHPC Roadmap for Health Care Reform will be an important starting reference for the work of the Board and the subcommittees.
 - Request OHPC members' participation in either the Financing Subcommittee or Delivery System Subcommittee, depending on their area of interest.

Commissioners

- **Commissioners shared their thoughts on the following issues:**
 - Need to clarify how staff time and resources will be split between the Commission and Health Fund Board.
 - Financing mechanism and delivery system are significantly different subject matters. Want to figure out who will participate in each subcommittee.
 - When recommendations from subcommittees have conflicts, need a process for prioritizing and negotiating.
 - Need to clarify OHPC's role (as a whole commission) in implementing SB 329.
 - Need to identify how Subcommittee and Commission issues will be sent to Oregon Health Fund Board.
 - Political support must be raised for health reform to be operationalized.
 - Should identify other issues in which OHPC would like to be involved.

- **OHPC and SB 329 implementation:**
 - Commissioners expressed support for the OHPC supporting and collaborating with the Health Fund Board to implement SB 329.
 - The following for next steps were identified:
 - (1) Identify subcommittees on which members will participate;
 - (2) Avoid duplicated work across subcommittees;
 - (3) Prioritize deliverables;
 - (4) Determine how each group will work together; and
 - (5) Figure out how each group's work will fit in health reform work as a whole.

IV. OHPC review of proposed initiatives for 2007-2008

Gretchen Morley

- **SB 329 planning (Exhibit C):** The Board will get recommendations from five subcommittees, with members coming from existing commission members, content experts and other interested parties. While the Quality & Transparency workgroup is not mentioned in the document, Q&T will be part of the process.

Approved December 12, 2007

- **Health Reform Collaborative:** The Commission approved the OHPC staff's continuous involvement. Gretchen will provide information on the Collaborative's work and put forward suggestions to the Collaborative received from the Commission.
- **Community Health Priorities (CHP) project:** The project, a partnership between the OHPC, the Northwest Health Foundation, and the DHS Public Health Division, is focused on engaging Oregonians in defining health priorities and policies. The project group created an initial progress report, which is available at www.communityhealthpriorities.com. A fall work outlining next steps is being developed and will be shared with the Commission.
- The Commission approved the proposed work plan overview and continued involvement in the Health Reform Collaborative and CHP.

V. Other updates

- **State Coverage Institute:** OHPR put together a team and will get assistance from national experts on health reform. Fourteen states are participating in the Institute.
- **RWJF Consumer Voices grant:** The Oregon Health Action Campaign is the lead applicant, which is intended to provide assistance for consumer input into reform. OHPC and the Health Reform Collaborative are providing input in the application development. The grant application is due in September.

II. Approval of August minutes

- August 16, 2007 minutes approved as submitted.

Kerry Barnett **III. Discussion of OHPC Work Plan**

- SB 329 participation
- Chair stated the work of the OHPC set the foundation for SB 329 and OHPC representation on the Oregon Health Fund Board and Committees is furthering the work of OHPC at this time. However, need to assess work outside of SB 329 that Commission needs to be addressed. Does not see Commission as being on hiatus but very active in supporting the goals of the Commission on SB 329 work at this time.

- Chair stated that Representative Greenlick is supportive of SB 329 but is concerned that the OHPC has not met since August and other OHPC work needs to continue its work outside of SB 329. He invited input from other commissioners regarding future meetings, given members' involvement in the current SB 329 committees and staff's limitations.

Discussion

- Felt legislative reality is that the Commission's support is needed to make SB 329 work.
- A majority of members on the Commission are members of Oregon Health Fund Board (OHFB), Committees, and Work Groups. Staff resources are also limited to also commit to OHPC work until after the February Legislative session.
- Suggestion to request funding for additional staff resources from Legislature. However, Senator Devlin indicated that the projected low revenue forecast may not support additional funding.
- Need to identify what aspects are not being addressed by SB 329 work that needs OHPC attention.
- Suggested OHPC focus on SB 329 now and the larger picture, and check with legislature and the Governor about the Commission's priority and role after the February legislative session.
- Motion by Gates, second by Lussier, to endorse the Work Plan as submitted to not meet in January but hold the next OHPC meeting in early March following the February Legislative session.

III. Other Updates (State Coverage Institute and Consumer Voices RWJF grants)

- OHPR has applied for a RWJF grant regarding SB 329 and a RWJF Consumer Voices grant.
