OPDP was formed by 2003 legislation to create a purchasing pool that leveraged the buying power of group business with the buying power of cash paying uninsured residents. The resulting pool benefits both populations by driving health costs down as more Oregonians access needed prescriptions.

In 2007 ODS began administering the Oregon Prescription Drug Program (OPDP), ensuring transparent pricing, low costs and best-in-class partnerships. OPDP has a comprehensive network of pharmacies that includes all major chains as well as most independent pharmacies in the state. Convenient home delivery is also available through Wellpartner's mail order pharmacy.

ODS has expanded OPDP's business options while statutory changes have expanded its pool of eligible groups. A full range of benefit options are available as are both fully insured and alternate funding arrangements. OPDP is open to all public and private sector groups. An interstate Consortium with Washington has also expanded its purchasing power.

Low costs & High value

With the purchasing power of the OPDP, groups generally receive savings between 3% and 5% on total annual prescription drug cost. Combine that savings with bestin-class customer care and you get a winning combination for everyone! ODS has given all OPDP groups financially backed service guarantees.

Transparent pricing so you know exactly what you're paying for

OPDP groups are charged the contracted rates that pharmacies agreed to provide in their contract. In other words there is no "spread" taken between what the group is charged and the pharmacy is paid. There is also 100% pass through for any credits received from drug manufacturers to the groups.


ODS reporting is available down to the National Data Code (NDC) label on each drug, allowing your group to tie manufacturing rebate reporting to management utilization reporting.

Frequently asked questions!

How was OPDP formed?

The OPDP was formed through the passage of SB 875 in 2003 and launched in 2005. In 2006 OPDP joined with Washington's Prescription Drug Program to form an interstate consortium that has the potential to grow to 10 million lives.

Who administers the OPDP?

In 2006, The ODS Companies was awarded the administration of OPDP and the entire interstate Consortium through a competitive bidding proc-

If one of my employees does not elect a prescription benefit can OPDP still help them?

Yes! OPDP was designed to pool all prescription purchasing. If an employee opts out of a group they may join OPDP at no cost as an individual member and take advantage of group valued discounts that have averaged 45% savings from billed charges. Individual members can enroll by calling 1-800-913-4146 or they may enroll online at www.OPDP.org. Uninsured residents are also eligible to join the program at no cost and no age or income restrictions.

Is OPDP limited to groups in Oregon?

The OPDP is limited to groups headquartered in Oregon. However OPDP's chain pharmacies honor OPDP rates throughout the country where your employees may live. Many individual pharmacies in neighboring states have also joined the OPDP network to accommodate group employees.

Groups headquartered in Washington may enter the Consortium through the WPDP by calling 1-800-578-1402.
