Notice of Intent to Award Contract

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of Kau Hospital a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to award a contract to Joshua Green M.D. a sole proprietor under the laws of the State of Hawaii.

Kau Hospital, designated as a Critical Access Hospital in July 2001, serves a critical role in the delivery of health care in the vast rural area located approximately 25 miles beyond Volcanoes National Park Headquarters on the Island of Hawaii. As a Critical Access Hospital, it serves as a sole provider of emergency care in its service area. Because of the isolated location of the Hospital, it has always had difficulty recruiting or retaining sufficient numbers of qualified physicians to provide the necessary coverage's for its emergency room.

The Scope of Services to be performed by Dr. Joshua Green includes:

Provide emergency room coverage at the Kau Hospital in accordance with the schedule for such coverage set forth by the Hospital.

Comply with:

1. The policies, practices, and directions of the Hospital;
2. The Bylaws, Rules and Regulations of the Medical Staff;
3. The standards and recommendations of the Joint Commission on Accreditation of Healthcare Organizations ("JCAHO");
4. The applicable standards of relevant professional societies; and
5. All applicable local, state, and federal laws and regulations.
6. Respond to and be available in the Emergency Room or the Hospital within 30 minutes of the request to provide care for patients at the Hospital, including both inpatients and patients registered in the Emergency Room.

Time of Performance

Dr. Joshua Green's time of performance will be between May 23, 2005 and May 22, 2006, with two (2) one year options to extend.
