**Notice to Amend Contract**

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of Ka'u Hospital a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to amend a contract with Joshua Green M.D.. HHSC desires to amend the Agreement so as to allow Joshua Green M.D. to provide additional 36 days of call service for a total of 85 total days of call service. The Agreement shall remain the same; the parties only desire to adjust the not-to-exceed number of days of services and the not-to-exceed amount of the compensation for the call services to reflect the additional 36 days of call services.

**The Scope of Services to be performed by Dr. Joshua Green includes:**

Provide a total of 85 days of emergency room coverage at the Ka'u Hospital in accordance with the schedule for such coverage set forth by the Hospital.

**Comply with:**

1. The policies, practices, and directions of the Hospital;
2. The Bylaws, Rules and Regulations of the Medical Staff;
3. The standards and recommendations of the Joint Commission on Accreditation of Healthcare Organizations ("JCAHO");
4. The applicable standards of relevant professional societies; and
5. All applicable local, state, and federal laws and regulations.
6. Respond to and be available in the Emergency Room or the Hospital as soon as possible within 30 minutes of the request to provide care for patients at the Hospital, including both inpatients and patients registered in the Emergency Room.

**Contract Amount**

The revised Not to Exceed Value of the contract is One Hundred Twenty-three Thousand Eight Hundred Eighty-seven and 00/100 Dollars (\$123,887.00).

Anyone wishing to protest the award of this contract shall submit an objection, in writing, no later than 4:30 p.m. on May 21, 2006, to:
