#### Susan M. Clark, M.A.

In October 1996, Susan Clark was appointed Assistant Director for Program Management of the Office on Women's Health (OWH) in the Department of Health and Human Services. Ms. Clark began her career in Federal service in March 1977. She has a broad range of management and administrative experience in Federal contract acquisition, budget strategy, and program development. Ms. Clark received her undergraduate and graduate degrees in Social Psychology from the University of Maryland. In her current position as Division Director in the OWH, she is responsible for setting priorities for the planning, monitoring, and direction of multi-year contracts, and for program planning and evaluation. Additionally, Ms. Clark is the Project Officer for the National Centers of Excellence in Women's Health program.

Prior to this appointment, she served as Special Assistant to the Director, National Heart, Lung and Blood Institute; a psychologist in the National Institute of Neurological and Communicative Diseases and Stroke; as a social science analyst in the Office of the Director, NIH; and as a program analyst in the Health Resources and Services Administration. Among the honors she has received are numerous superior performance, recognition, and special achievement awards.

#### Wanda K. Jones, Dr.P.H.

Dr. Wanda K. Jones is Deputy Assistant Secretary for Health (Women's Health) of the U.S. Department of Health and Human Services. Until being selected for this position in February 1998, she was the Associate Director for Women's Health at the Centers for Disease Control and Prevention. Prior to that, she was the Assistant Director for Science in the Office of the Associate Director for HIV/AIDS. A Penn State graduate in medical technology, she has worked in an inner city hospital blood bank and in its hematology laboratory; in a small town hospital as its night shift technologist and then as its microbiologist; and for a State public health laboratory as a laboratory improvement consultant. After obtaining her doctorate in Public Health Laboratory Practice from the University of North Carolina, Dr. Jones joined CDC in 1987 as an HIV laboratory trainer. In 1990, she moved to the Office of HIV/AIDS, where she was active in policy issues related to HIV laboratory testing, women and AIDS, HIV vaccine development, and healthcare workers. She is recognized for her leadership on women's health issues in the Federal and State public health communities.

#### Cristina Beato, M.D.

Dr. Cristina Beato serves as the principal advisor to the Assistant Secretary for Health in substantive program and political matters, in policy and program development, and in setting legislative priorities. She also provides advice and counsel to the Secretary on public health and science issues. Dr. Beato is a University of New Mexico (UNM) magna cum laude graduate. She did her internship at UNM and was the youngest woman Chief Resident in Family, Community and Emergency Medicine. She is board certified in Family Medicine.

Dr. Beato joined the UNM School of Medicine faculty after her residency as an assistant professor and medical director of UNM Occupational Clinic, a facility she established and developed to provide streamlined, one-stop, comprehensive care for 13,000 employees from four agencies. She then joined the Office of the Dean, UNM Medical School, as Medical Director for Risk Management and Operations. She was promoted to Assistant Dean for Clinical Affairs and assumed oversight of clinical operations at the UNM hospital, and later became Associate Dean for Clinical Affairs, Medical Director for UNM Health Sciences Center (HSC), Chief Medical Officer, and was the first woman at UNM HSC to achieve the rank. In this position she was responsible for 1,000 physicians, five hospitals, over \$500 million budget, and the integration of academia, clinical research, and patient care in the only level-one trauma center and tertiary-quaternary care center in the state.

Dr. Beato was a strategic leader in developing a plan for academic medical centers to increase their focus on research to offset financial pressures of decreasing clinical revenues. She is also a child advocate and has testified as an expert witness in dozens of cases, not losing one. Dr. Beato has served on various boards at AAMC, AAFP, and the State of New Mexico. She is very active in her community serving on boards that address and deal with domestic violence and abuse issues and access to quality education for children.

#### Harold F. Freeman, M.D.

Dr. Harold F. Freeman has served as Associate Director of the National Cancer Institute (NCI) and Director of the NCI Center to Reduce Cancer Health Disparities since June 2000. He is Professor of Clinical Surgery at the College of Physicians and Surgeons, Columbia University, and Director of Surgery at North General Hospital, New York, NY. Dr. Freeman was appointed Chair of the President's Cancer Panel in 1991 by President Bush, and served as Chair until June 2000. He continues to serve as a member of the Panel. He also served for 25 years as Director of Surgery at Harlem Hospital Center.

Dr. Freeman was born in Washington, DC, and graduated from the Catholic University of America, where he received the Harris Award for Outstanding Scholar, Gentleman, and Athlete. He graduated from Howard University Medical School, Washington, DC, and completed his internship and residency in General Surgery at Howard University Hospital, where he received the Daniel Hale

Williams Award for Outstanding Achievements as Chief Resident. He served as Senior Resident in Cancer Surgery for three years at Memorial Sloan-Kettering Cancer Center in New York City. Dr. Freeman served as National President of the American Cancer Society from 1988 to 1989. He is the chief architect of the American Cancer Society's Initiative on Cancer and the Poor and is a leading authority on the interrelationships among race, poverty, and cancer. In recognition of his leadership on this issue, the Harold P. Freeman Award is given annually in ACS divisions throughout America to individuals who have made outstanding contributions to the fight against cancer in the poor.

Dr. Freeman is a Diplomat of the American Board of Surgery, a Fellow of the American College of Surgeons, and a Fellow of the American Surgical Association. He has been a member of the Executive Committee of the Board of Governors of the American College of Surgeons and the Executive Council of the Society of Surgical Oncology. He has been Medical Director of the Breast Examination Center of Harlem, a program of Memorial Sloan-Kettering Cancer Center, since 1979. In 1997, Dr. Freeman was elected to membership in the Institute of Medicine of the National Academy of Sciences. He has been awarded Honorary Doctor of Science degrees from Albany Medical College, Niagara University, Adelphi University, and the Catholic University of America.

#### Joseph Bordogna, Ph.D., B.S.E.E., S.M.

Dr. Joseph Bordogna is Deputy Director and Chief Operating Officer of the National Science Foundation and previously served as head of NSF's Directorate for Engineering. Complementing his NSF duties, he is a member of the President's Management Council; has chaired Committees on Manufacturing, Environmental Technologies, and automotive technologies within the President's National Science and Technology Council; and was a member of the U.S-Japan Joint Optoelectronics Project. Prior to his appointment at NSF, he served at the University of Pennsylvania as Alfred Fitler Moore Professor of Engineering, Director of The Moore School of Electrical Engineering, Dean of the School of Engineering and Applied Science, and Faculty Master of Stouffer College House, a living-learning student residence at the University.

Dr. Bordogna has made contributions to the engineering profession in a variety of areas including early laser communications systems, electro-optic recording materials, holographic television playback systems, and early space capsule recovery. He was a founder of PRIME (Philadelphia Region Introduction for Minorities to Engineering) and served on the Board of The Philadelphia Partnership for Education, community coalitions that provide supportive academic programs for K-12 students and teachers.

Dr. Bordogna received the B.S.E.E. and Ph.D. degrees from the University of Pennsylvania and the S.M. degree from the Massachusetts Institute of Technology. As well as his assignment at NSF, his career includes experience as a line officer in the US. Navy, a practicing engineer in industry, and a professor. He is a Fellow of the American Association for the Advancement of Science (AAAS), the American Society for Engineering Education (ASEE), the Institute of Electrical and Electronics

Engineers (IEEE), and the International Engineering Consortium. He also served his profession globally as president of the IEEE.

#### Molly Carnes, M.D.

Dr. Molly Carnes did her undergraduate work at the University of Michigan and received her M.D. from the State University of New York at Buffalo. She trained in Internal Medicine and Geriatrics at the University of Wisconsin, where she earned a masters of science degree in population health. At the University of Wisconsin, Dr. Carnes is a Professor in the Departments of Medicine and Psychiatry. She directs the Women's Health Fellowship, the NIH postdoctoral training grant in Women's Health and Aging, the Center for Women's Health and Women's Health Research (a National Center of Excellence), and the Women Veterans Health Program. She is co-director of an Institutional Transformation Award from the National Science Foundation, which will focus on the development and evaluation of strategies to increase participation and the advancement of women in academic science and engineering.

While Dr. Carnes' early research was devoted to the study of rhythms of stress hormones in male rats, her major professional contributions are in academic program development in Geriatrics and Women's Health. Dr. Carnes is committed to transforming the academic culture to be more welcoming of women and supportive of their career advancement, and is using women's health research as a venue to accomplish this. In 1999, she became the first Jean Manchester Biddick Professor of Women's Health Research. She is the recipient of the 2001 Addis Costello Internist of the Year Award by the American College or Physicians American Society of Internal Medicine-Wisconsin Chapter, and the 2002 YWCA Woman of Distinction Award. Dr. Carnes is now listed as one of "America's 2002 Best Doctors" based on national surveys of colleagues.

#### Vivian W. Pinn, M.D.

Dr. Vivian W. Pinn is the first full-time Director of the Office of Research on Women's Health (ORWH) at the National Institutes of Health (NIH), an appointment she has held since November 1991. In February 1994, she was also named as Associate Director for Research on Women's Health, NIH. Dr. Pinn earned her B.A. from Wellesley College, and her M.D. from the University of Virginia School of Medicine. She completed her postgraduate training in Pathology at the Massachusetts General Hospital, during which time she also served as a teaching fellow at the Harvard Medical School. She has also been Assistant Dean for Student Affairs and Associate Professor of Pathology at Tufts University School of Medicine, and Chair of the Department of Pathology at Howard University College of Medicine and Howard University Hospital. She served as the president of the National Medical Association during the year 1989-1990.

Dr. Pinn has long been active in efforts to improve the health and career opportunities for women and minorities. She has been invited to present the ORWH's mandate, programs, and initiatives to many national and international individuals and organizations with an interest in improving women's health and the health of minorities. She led a national effort to reexamine priorities for the women's health research agenda for the 21<sup>st</sup> century, involving over 1,500 advocates, scientists, policymakers, educators, and health care providers, in a series of scientific meetings across the country to determine progress as well as continuing, or emerging, areas in need of research.

Dr. Pinn has received numerous awards and recognitions. Among the more recent, she was included among "A Dozen Who Have Risen to Prominence in Women's Health" in the June 1997 New York Times Women's Health Section, and she was named the 1997 Excellence in Leadership in the Public Sector Honoree by the National Women's Economic Alliance Foundation. The American College of Physicians awarded Dr. Pinn the James D. Bruce Memorial Award in 1998 for distinguished contributions in preventive medicine; she was awarded the Athena Award in February 1999 from the Partnership for Women's Health at Columbia University; she was honored by the North American Menopause Society in September 1999; and in March 2000 she received the Catherine McFarland Award from the University of Pennsylvania for distinguished service in women's health. In October 2000, the Association of American Medical Colleges honored Dr. Pinn with the 2000 Women in Medicine Leadership Award; in October 2000, the national Organization for Women honored Dr. Pinn for her leadership and contributions to women's health; and in September 2000, Dr. Pinn was awarded the Commonwealth Fund's Margaret E. Mahoney Award for Outstanding Service for work in advancing the quality of healthcare for women. In April 2001, Dr. Pinn was honored by the establishment at the University of Virginia School of Medicine of a lectureship named the "Vivian W. Pinn Distinguished Lecture in Health Disparities." The Women's Health Section of the National Medical Association also established a "Vivian Pinn Symposium on Women's Health" named in her honor. In January 2002, Dr. Pinn was awarded the "Trumpet Award, Tower of Power Award" from Turner Broadcasting System, Inc., celebrating the contributions of African Americans who have helped shape America.

#### Gloria E. Sarto, M.D., Ph.D.

Dr. Gloria E. Sarto received her M.D. and Ph.D. from the University of Wisconsin. She has been on the faculties of the University of Wisconsin, Northwestern University, and the University of New Mexico, where she served as chair of the Department of Obstetrics and Gynecology. She has had a lifetime commitment to improving the health of women through research and training of physicians. Dr. Sarto is immediate past President of the Society for Women's Health Research, of which she was a founding member. In October 2002, Dr. Sarto was named President-elect of the American Gynecological and Obstetrical Society.

Currently, Dr. Sarto is involved in national efforts to advance the research agenda in Women's Health. She is on the Board of Directors of the National Center for Genome Resources and serves on the Board of Health Sciences Policy of the Institute of Medicine and was a member of the IOM Committee on a Vision for Space Medicine Beyond Earth Orbit. Presently, she is Professor of Obstetrics and Gynecology at the University of Wisconsin Medical School, Co-Director of the U.W. National Center of Excellence in Women's Health, Co-Director of the Center for Women's Health and Women's Health Research and serves as Special Assistant to the Dean for Gender Issues.

Dr. Sarto has participated in numerous NIH study sections and national panels, including the National Advisory Council on Child Health and Human Development, NIH; the Advisory Committee of The Office of Research on Women's Health, NIH; and Agency for Health Care Policy and Research. She has served as the first female director and the vice president of the American Board of Obstetrics and Gynecology, and as director of its Maternal-Fetal Medicine Division. She has been a member and chair of the Residency Review Committee for Obstetrics and Gynecology. She was a member and chair of the American College of Surgeon's Obstetric and Gynecology Advisory Council. She was also a member of the Task Force on the NIH Women's Health Research Agenda for the 21st Century, and participated in a series of workshops. Dr. Sarto is

a recipient of the American Medical Women's Association Distinguished Career Award and the Association of Women's Surgeon Distinguished Member Award. More recently, Dr. Sarto was awarded the University of Wisconsin Medical Alumni Award Citation for 2001, the highest annual honor.

#### Nathan Stinson, Jr., Ph.D., M.D., M.P.H.

RADM Nathan Stinson, Jr. became the Deputy Assistant Secretary for Minority Health and the Director of the Office of Minority Health on August 2, 1999. The Office of Minority Health was created by the U. S. Department of Health and Human Services (HHS) in 1985 as a result of the Report of the Secretary's Task Force on Black and Minority Health. The office operates under the provisions of the Health Professions Education Partnerships Act of 1998, and its mission is to improve the health of racial and ethnic populations through the development of effective health policies and programs that help to eliminate health disparities and gaps. These populations include Blacks/African Americans, American Indians and Alaska Natives, Asian Americans, Native Hawaiians and Other Pacific Islanders, and Hispanics/Latinos.

As Deputy Assistant Secretary, Dr. Stinson reports to the Assistant Secretary for Health/Surgeon General and works closely with all agencies throughout the Department. Under Dr. Stinson's leadership, the Office of Minority Health develops and coordinates Federal health policy that addresses minority health concerns and ensures that Federal, State, and local health programs take into account the needs of disadvantaged, racial, and ethnic populations. Dr. Stinson also oversees regional minority health consultants at the 10 HHS regional offices. Dr. Stinson was appointed Rear Admiral, Assistant Surgeon General, in the Commissioned Corps of the U.S. Public Health Service on May 1, 2000.

Dr. Stinson has served in a variety of positions with the Department of Health and Human Services. As Director of the Division of Programs for Special Populations, Bureau of Primary Health Care, Health Resources and Services Administration, from 1997-1999, Dr. Stinson directed the \$120 million health care delivery system for people who were homeless, residents of public housing, and other special populations. He served as Deputy Director, Division of Community and Migrant Health, from 1992-1997 and as Branch Chief of the Clinical and Professional Activities Branch in the Division of National Health Service Corps from 1989-1992. He was a Clinical Program Consultant to the Associate Director of the Indian Health Service, Office of Health Programs, from 1988-1989 and served as a primary care physician on the Navajo Reservation at Chinle and Kayonta, Arizona, from 1984-1988. Since February 1, 1999, Dr. Stinson served as the Acting Deputy Assistant Secretary for Minority Health.

Dr. Stinson received his bachelor's degree from the University of Colorado, a master's degree from the University of Colorado, all in Environmental Biology. He obtained his MD from the University of Colorado Medical School and an MPH in Health Care Administration from the Uniformed Services University of Health Sciences. His decorations include the Outstanding Service Medal, the Surgeon General's Exemplary Service Medal, and the Crisis Response Service Award.
