The Recreation Enhancement Act

Recreation fees – it is your money and you should know what happens to it. The Federal Lands Recreation Enhancement Act (REA) authorized in December 2004, recognized this and required all agencies to share accomplishments that occur on recreation fee sites.

Because of REA, each Forest now retains 95% of the funds collected. Of that, at least 80% is used to help improve and maintain the facilities and services that visitors use and expect.

Fee dollars may only be spent on recreation facilities or services where a fee is charged. In the past we have heard that people would like to see fees spent on clean recreation sites, well-maintained roads and trails, friendly helpful employees, and safety and security at recreation sites.

The Salmon-Challis National Forest collects fees for recreation use on the Middle Fork and the Main Salmon Rivers in the Frank Church-River of No Return Wilderness. Fees from lottery applications and permits are used to improve the services provided for users of the Middle Fork and the Main Salmon Rivers. The non-refundable lottery application fee is \$6/application; if granted a permit, the Forest charges a \$4 per-person, per-day user fee. Season Passes entitle the pass holder to float the Middle Fork and/or Main Salmon Rivers without further payment for one year from the date of purchase.

Fees collected at the campgrounds and cabin rentals help pay for maintenance of that site, firewood at the cabins, and providing recreation guards to keep the sites clean.

The forest continued with:

- treating noxious weeds in the high use Main and Middle Fork Salmon River corridors and around campsites;
- two river patrols on both the Main and Middle Fork rivers (about 30 total patrol rotations);
- trail maintenance, emergency repairs and limited reconstruction on the mainline Middle Fork trail system, the trail from Boundary Creek boat ramp to the Dagger Falls fish ladder and two of the main portal trails to the river corridor (about 100 miles total);
- piloted a successful program to issue small contracts to outfitters to complete trail maintenance and clearing on specific trails;
- continued the Shoshone-Bannock Tribes native American interpreter program;
- provided checkers at both of the main river portals at Corn Creek and Boundary Creek who assign campsites, provide an interpretive and safety introduction to the rivers, continue the agreement with USGS for operation of the Middle Fork gauge;
- operation of the 4-River Lottery for the main and Middle Fork Salmon rivers, the Selway and Hells Canyon;
- operation and maintenance of 2 SCAT machines, one each at the upper and lower end of the Main Salmon access portals

2007

The forest provided:

- Planning and design for Salmon River Sites on the Nez Perce NF Carey Creek,
 Vinegar Creek, Spring Bar, and Wind River Trailhead.
