Brown) on the 17th day of Aug. 1861, to serve three years, was born in Chequamegon, Bradford County, State of Pa. is 25 years of age, 5 feet 4 1/2 inches high, fair complexion, grey eyes, dark hair, & by occupation when enlisted a Farmer. The said James S. Foster was killed in the battle of Murfreesboro Tenn Dec. 31, 1862.

His effects were all lost on the battle field.
