### SPECIAL POINTS Of interest:

- MAP: The new Motor Vehicle Use (MVU) Map will be available at all Eldorado National Forest offices and stations, as well as, online.
- ROUTE MARKERS: Open routes will be marked on the ground. If the road or trail does not have a route marker or is not shown on the new MVU map, it will not be legal to drive on.
- CALIFORNIA VEHICLE CODE (CVC): The CVC applies throughout California, including on National Forest Lands.

### **CHANGES TO MOTOR VEHICLE USE**

The Forest Service will soon be complying with a court order to keep all motorized travel in the Eldorado National Forest on system roads and trails. A free Motor Vehicle Use Map defining the travel system will be available soon.

### WHAT CHANGES CAN YOU EXPECT?

Beginning in summer 2005, motor vehicles will be allowed to operate on only the 2,200 miles of system roads and motorized trails. Paved roads are legal travel routes if your vehicle is licensed to operate on highways. All non-system routes will be closed by court order and interim Forest Order.

- Cross-Country Travel: Use of motorized vehicles for cross-country travel will be prohibited.
- **User-Created Routes:** Over the years, visitors have created their own routes, or opened routes previously closed by the Forest Service to prevent environmental damage. These routes will be considered closed.
- **Restoration Areas:** The Forest Service is responsible for managing the national forest. Areas that have received resource damage from vehicle use (meadow damage, erosion, stream sedimentation, damage to archaeological sites, etc.) will continue to be closed, and restored or rehabilitated. These projects will be on-going.

### WHO DOES THIS AFFECT?

This court order applies to all motorized vehicles including, but not limited to: cars, trucks, four-wheel drives, motorcycles, all-terrain vehicles (ATVs) and sand buggies. As such, this affects more than the Off-Highway Vehicle recreationists. If you camp outside of developed campgrounds or hunt, for example, you may also be affected. Some of the access routes to remote spots along a river, stream or lake are routes created over the years by visitors. If the route leading your campsite or hunting area is not signed or shown on the Motor Vehicle Use Map, it will no longer be open to your motorized vehicle.

- **Dispersed Campers:** You will still be able to camp free-of-charge just about anywhere in the National Forest, unless it is specifically prohibited. Your vehicle, however, will need to be parked on a route that is signed as open for motorized vehicles (or within a reasonable distance so as not to block the roadway or create a safety hazard). You may not travel beyond gates and barriers.
  - Hunters: Some visitors scout hunting spots by patrolling the back roads in their vehicles. Keep in mind that some of the roads previously used may not be open for motorized travel. You will still be able to use your non-motorized game cart.
- Wood Cutters: Access off system roads will be allowed according to the terms of your woodcutting permit. Please read all the instructions when you purchase your permit.

# WHEN WILL THESE CHANGES GO INTO EFFECT?

These changes are estimated to be in effect by August 2005.

### **ROUTE DESIGNATION PROJECT IN PROCESS**

The court ordered changes in Motorized Vehicle Use on the Eldorado National Forest have been incorporated into an ongoing Route Designation Process. Throughout the country national forests are committed to designating route systems. In California, a 5-step planning process is being implemented. The Eldorado National Forest is asking for public review of the Step 1 Route Inventory. The court order will dictate how the Step 2 Interim Forest Orders are implemented.
