Green Badges



- Local, site-specific badges
- Issued for up to 6 months
- DOE N 206.3, 4.a.(6)

"Individuals who do not require a DOE security badge, including short-term (6 consecutive months or less) uncleared contractors, but require access to DOE facilities are issued badges consistent with Departmental policies and local procedures."

- August 25 Lingan memo, "Issuance of Local (Non-PIV–Green) Badges as Interim Badges for PIV-Badge Applicants"

"Local badges [will be issued] to PIV badge applicants 14 to 17 calendar days after the PIV paperwork is received in Personnel Security."
