


Total Recordable Case (TRC) Rate

- The SC complex had 113 cases through 2Q07.
- The SC TRC rate for the first two quarters of FY 2007 (Oct. 2006-Mar. 2007) was 1.04, a 22 percent decrease from the FY06 rate of 1.27.
- From FY02 to FY06, TRC cases decreased from 593 to 283, a 52 percent drop that reduced TRC injuries by 310.



Days Away, Restricted, or Transferred (DART) Case Rate


- The SC complex had 43 cases through 2Q07.
- The SC DART rate for the first two quarters of FY 2007 (Oct. 2006-Mar. 2007) was 0.40, the same rate as FY06 rate.
- From FY02 to FY06, DART cases decreased from 301 to 88, a 70 percent drop that reduced DART injuries by 213.




Total Recordable Case (TRC) Rate

- The 12-month DART rolling average shows a slight downward trend and a significant lower rate than the DOE average.








Total Recordable Case (TRC) Rate
