

## CATTLE AND CALVES

New England's cattle and calf herd totaled 553,000 head on January 1, 2001, 3 percent below the previous year.

The beef cow inventory was 38,500 head, a decrease of 7 percent from the previous year.

The milk cow inventory was 265,800, a decrease of 3 percent.

Although inventories decreased, the value per head increased 2 percent from 2000 to \$941.

The six-state region's cattle and calf inventory, as of January 1, 2001,

were valued at \$520.6 million,

almost 3 million dollars decrease from the 2000 value because of the decreased inventory. Calves born in New England during 2000 totaled 271,800 head, almost 1 percent below the 1999 calf crop. Operations with one or more head at any time during 2000 decreased by 100 farms from the previous year to 8,650. Operations with at least one milk cow during 2000 accounted for 39 percent of all New England farms with cattle. According to the six State Departments of Agriculture (or their equivalents), there were 2,841 commercial dairies throughout New England in 2000, a loss of 160 operations from the previous year.
