CASH RECEIPTS

New England cash receipts from farm marketings totaled \$2.24 billion in 2005, three percent below 2004. Cash receipts from milk sales continue to be the top contributor to overall marketings, with \$681 million in sales in 2005. Greenhouse and nursery sales were the next largest cash contributor. Cash receipts from these two commodities comprised 54 percent of all farm marketings in the six-state region in 2005.

Crop sales in New England were estimated at \$1.13 billion in 2005, one percent above sales generated the previous year. The greenhouse and nursery industry remains New England's top contributor to crop sales, with 2005 cash returns at \$535 million, comprising 47 percent of the crops total. Increases in hay, tobacco, fall potatoes, vegetables and wild blueberries offset reductions in greenhouse/nursery, maple, cranberry and tree fruit sales. Wild blueberry sales were well above a year earlier due to a 29 percent increase in production, and shade tobacco sales were up 43 percent due to the increase in pounds marketed and price received from a year earlier.

New England livestock sales, at \$1.11 billion in 2005, were down seven percent from 2004, driven by the five percent drop in milk sales, and 31 percent decline in egg sales. Although more pounds of milk were marketed, average milk prices received by New England dairy farmers fell from \$17.20/cwt in 2004 to \$16.20/cwt in 2005. Fewer eggs sold and lower prices received translated to a \$40.4 million decline in chicken egg cash receipts in New England in 2005. Cattle and calf cash receipts were six percent higher in 2005 than a year earlier, with strong prices offsetting a four percent drop in marketings.

Cash receipts generated from milk secured **Vermont's** place as first in the region in 2005. The value of milk marketings totaled \$420 million in 2005, a four percent reduction from a year earlier due to declines in prices received. Dairy producers in Vermont received on average \$16.00/cwt for milk sold in 2005, compared with \$16.90/cwt for milk sales in 2004. Vermont milk sales remain the top individual contributor to the state total and New England total cash receipts. Sales from milk comprised 75 percent of Vermont's total cash receipts, and 19 percent of New England's total cash receipts. Farm marketings from crops and livestock totaled \$563 million in the state in 2005, three percent below the previous year.


Cash receipts generated from milk and fall potato sales secured **Maine's** place as second in the region in 2005. Total cash receipts from all agricultural commodities produced in the state totaled \$535 million, five percent below the previous year. Milk sales, at \$99 million, remained the top individual contributor to the state cash receipts' total in 2005. Potato sales followed, with \$91 million generated. Chicken eggs generated \$47 million in sales in 2005; fewer eggs produced coupled with lower prices resulted in a 34 percent drop in value from the previous year. Wild blueberry cash receipts in 2005 were almost double the previous year due to increased production and improved prices received.

Connecticut ranked third in the region in 2005 with \$511 million generated in the state, down fractionally from 2004. Connecticut's greenhouse and nursery industry contributed \$221 million in cash receipts for 2005, 43 percent of the state's total, and the second largest individual contributor to total New England cash receipts. Milk sales were the next largest contributor to Connecticut's cash receipts, with \$63 million in total revenue generated, six percent below the previous year.

Massachusetts followed with \$404 million in total 2005 cash receipts, three percent below the previous year. Greenhouse and nursery sales remained the top contributor to Massachusetts' total cash receipts in 2005, with sales at \$146 million. The next largest contributor to the state's receipts total was from cranberry sales. Improved prices in 2005 failed to offset the 21 percent decline in berries produced, which placed value at \$50 million, 16 percent below 2004 value, but four percent above 2003 value. Receipts from milk marketed in 2005 totaled \$47 million, seven percent below 2004 due lower output and prices.


New Hampshire's cash receipts totaled \$163 million in 2005, with greenhouse and nursery sales and milk comprising close to two-thirds of all receipts.

Rhode Island's greenhouse and nursery industry dominated the state's agricultural cash receipts, comprising \$42 million of the total \$64 million generated in cash receipts in 2005.
