Dear Ms. Nehring:

This letter addresses Schering Corporation's (Schering) dissemination of two television broadcast "reminder" advertisements for Claritin (loratadine) Tablets ("Spring" CR3430) and Claritin Syrup ("Goofing Around" CS0373). The Division of Drug Marketing, Advertising, and Communications (DDMAC) reviewed these advertisements as part of its monitoring and surveillance program and concluded that they are in violation of the Federal Food, Drug, and Cosmetic Act and applicable regulations.

Reminder advertisements call attention to the name of the drug product, but may not contain written, printed, or graphic matter containing representations or suggestions relating to the drug product. The overall presentation of the ads make a representation about the drug products, through the totality of the video images, especially the images of hay bales and loose hay flying around the actors' faces.

Schering should immediately cease using these television advertisements and all other promotional materials for Claritin that contain the same or similar claims or presentations. We should receive your written response no later than March 28, 2000, and it should list similarly violative materials, with a description of your method of discontinuation, and the discontinuation date.

DDMAC reminds Schering that only written communications are considered official.
