TITLE: Food, Laundry and Commissary Services – Metropolitan Detention Center

ACTION: Motion to:

1. Approve First Amendment to the Metropolitan Detention Center Food, Laundry and Commissary Services Agreement.

2. Authorize County Manager to execute future amendments to the Food, Laundry and Commissary Services Agreement.

SUMMARY:

The Purchasing Department issued RFP #03-02-DE, for Food, Laundry and Commissary services on July 9, 2001 which closed on August 17, 2001. The Agreement is for 8 years. Provisions of the RFP require services to be provided by a single vendor. Services include management and operation of all food, laundry, and commissary services at the MDC facility.

The amendment is necessary to address a cost of living increase of 6%. The Contractor has been providing the services at the MDC since 2001 and has not requested an increase until this year. Staff has negotiated the cost of living increase and the additional services to be provided by the Contractor. Additional services to be provided by the Contractor are laundering services for inmate undergarments at the MDC facility, and catering services for family counseling and therapy sessions and like events at the Metropolitan Assessment Treatment Services (MATS) Facility.

FISCAL IMPACT

The MDC Operating Budget BC87-531000-M1OP includes appropriations for meals and laundry, currently provided by MDC Staff. The increase to the contract for 2,700 inmates is \$264,428 for a total contract of \$3,110,238. Feeding 2,700 inmates including the CPI of 3% for 2006 and 2007 along with the laundry cost of .0350 increases the rate to \$1.0520 per meal.
