- Forum to Discuss Issues Outside of Spill Response Arena



- Pipeline Rupture 4 October 2000
- 330 bbls Unleaded Gasoline Discharged
- Unnamed Slough Tributary to Suisun Bay





Bay Point Factors Promoting Cooperation

- Existing Relationships With Trustees
- Trust
- Agreement to Cooperate a No-Brainer



Bay Point Factors Promoting Cooperation

- Ephemeral Data Collection: Joint Effort
- Common Laboratory Selected and Analytes Agreed Upon
- Jointly Conducted Habitat and Wildlife Assessment
- Jointly Measured Area of Injury
- Compared Field Notes
- Parties Stipulated To Wildlife Mortalities
- Result: Good Data Provided Foundation for Negotiation

Bay Point Factors Promoting Cooperation

- No Lawyers or Consultants at Meetings;
 Respective Lawyers Were "Kept in the Loop"
- Focused on Restoration
- Result: NRDA Settled After 2 Meetings, Effective Management of Transaction Costs



Challenges

- OPA NRDAs More Cooperative Than CERCLA NRDAs
 - Multiple RPs
 - Not an "Emergency"
 - Determining Injury
 - Baseline
 - Link to Remediation
 - No Foundation for Trust
- First Step More and Better Communication
