It is still unclear to Abt Associates whether offerors should submit 5 PPRs from each organization comprising a consortium? So, for example, would a consortium comprising a prime plus 3 subcontractors (total 4 organizations) be required to submit 20 PPRs -- 5 PPRs from each organization? Or, alternatively, would the consortium submit a total of 5 PPRs to reflect the entire consortium?
