2007 California Raisin Grape Overhead Trellis Report

RESULTS

California raisin-type grapes using the overhead trellis management system totaled 13,668 acres (bearing and non-bearing) during 2007. This amounted to 6.1 percent of the total raisin-type grape acreage. The Dovine and Fiesta varieties had the highest percentage of acreage using the overhead trellis system, at 56.3 percent and 38.7 percent, respectively. Approximately 31 percent of the total raisin-type acreage planted since 2001 was managed using this system. In Madera County, 14 percent of the raisin-type acreage were grown using overhead trellises, followed by 12.1 percent in Kern County and 12 percent in Kings County. Only 3.4 percent of Fresno County's acreage was devoted to this system.

Most California raisins are produced by sun drying after laying the bunches on paper trays on terraces between vine rows. The overhead trellis system has led to increased production of dried-on-the-vine raisins, increased machine harvesting, and decreased hand labor use.

PROCEDURES

The California Field Office of USDA's National Agricultural Statistics Service, in cooperation with the California Department of Food and Agriculture, conducts

an annual grape acreage survey. The 2007 Grape Acreage Report, published in April, summarized the latest survey results. At the request of the raisin industry, an additional question was added to the grape acreage survey form the past three years to gather information on raisin-type acreage grown using an overhead trellis system. In addition to the overhead trellis system data, producers were asked to update acreage by variety and year planted. Growers were first contacted by mail with telephone follow-up. Field staff personally visited large growers who did not respond by mail. This report summarizes data for raisin-type grapes grown using the overhead trellis system.
