During his presentation, Mr. Marinelli noted the following amendments:

 Page 3, Lines 15 and 16, Amend the sentence to read:

"Pursuant to 11 CFR 114.8(d)(4), the Associated Builders and Contractors will obtain prior approval forms with respect to each calendar year, as well as the permission forms authorizing withdrawals."

 Page 4, Line 1, at the beginning of the new sentence it should read:

"If there is a monthly individual contribution of more than \$50, the transfer...."

 Page 6, Line 11, insert a new paragraph as follows:

"The Commission emphasizes that the described PAC checking account deduction program may only be utilized by personnel who qualify as members of the 'restricted class' of ABC and its State affiliates.

11 CFR 114.1(c),(h) and (j) and 114.8(c). In addition, all contributions made through the checking account deduction process must comply with Commission regulations that require them to be voluntary. See 11 CFR 114.1(i), 114.5(a) and 114.8(e)(4)."
