Chairman Wold recognized Mr. Michael Marinelli of the General Counsel's Office who presented draft Advisory Opinion 1999-37 concerning the application of the Federal Election Campaign Act of 1971, as amended ("the Act"), and Commission regulations to X-PAC's proposed political advertising that would promote use of the Internet to make independent expenditures.

- 6. Page 7, Line 5: Delete the word "allocated" and substitute the word "attributed" in lieu thereof;
- 7. Page 8, Line 3: After "\$441d" change the comma to a semi-colon.

# IV. EXPRESS ADVOCACY RULE (11 CFR 100.22(b))

(Held over from meeting of February 3, 2000)

Agenda Documents No. 00-11 and No. 00-13

Chairman Wold recognized Commissioner Mason who presented his reasons why 11 CFR 100.22(b) should be repealed.

Following discussion, Chairman Wold recognized Commissioner Mason, who

MOVED to instruct the Office of General Counsel to initiate a rulemaking to repeal 11 CFR 100.22(b).

The motion failed in a vote of 2-3 with Commissioners Mason and Wold voting affirmatively; Commissioners McDonald, Sandstrom, and Thomas dissented. Commissioner Elliott was not present.

## V. <u>2000 LEGISLATIVE RECOMMENDATIONS</u>

(Held over from meeting of February 3, 2000)

Agenda Documents No. 00-12 and 00-12-A

Chairman Wold recognized Vice Chairman McDonald, who

MOVED to suspend the rules on the timely submission of agenda documents in order to consider Agenda Document No. 00-12-A.

The motion carried on the vote of 5-0 with Commissioners Mason, McDonald, Sandstrom, Thomas, and Wold voting affirmatively.

Chairman Wold recognized Ms. Louise Wides,
Assistant Staff Director, Information, who stated
Ms. Dorothy Yeager, Senior Public Affairs Specialist,
would present the draft legislative recommendations
for Year 2000. Ms. Yeager noted there were 38 legislative recommendations carried over from the preceding
year and one suggested new recommendation.

Ms. Bobby Zarin, Deputy Assistant Staff
Director, Information; Ms. Rosemary Smith, Assistant
General Counsel; and Ms. Tina VanBrakle, Congressional
Affairs Officer; participated in the discussion.

## V. 2000 LEGISLATIVE RECOMMENDATIONS

(continued)

Without objection, the Commission agreed to the following with respect to Year 2000 Legislative Recommendations:

- 1. Circulate on tally vote the following six priority recommendations, including the proposed legislative language:
  - a) Election Cycle Reporting of Operating Expenditures and Other Disbursements;
  - b) Application of \$25,000 Annual Limit;
  - c) Contributions by Foreign Nationals;
  - d) Lines of Credit and Other Loans Obtained by Candidates;
  - e) Monthly Reporting for Congressional Candidates;
  - f) Waiver Authority.
- Objection to any recommendation on the priority list would place that recommendation in the secondary package.
- 3. Delete from the secondary package the proposed recommendation entitled:

  <u>Subpoena and Reason-to-Believe</u>

  <u>Notification Signature Authority.</u>
- 4. Change the title of the recommendation Enhancement of Criminal Provisions to Referral of Criminal Violations.

# V. <u>2000 LEGISLATIVE RECOMMENDATIONS</u>

(continued)

 Lack of four affirmative votes would remove the recommendation from the secondary package.

## VI. <u>ADMINISTRATIVE MATTERS</u>

Chairman Wold recognized Staff Director Pehrkon who reported, beginning February 1st, all open meeting agendas and agenda documents became available on the FEC Web site, mentioning documents become available to the public after 2:00 p.m. two days prior to the meeting.

Regarding the state paper-filing waiver,
Mr. Pehrkon stated an additional 10 states have been
certified by the Commission, making a total of 33 states
exempt from a federal requirement to retain paper copies
of campaign finance reports.
