22	poena is returnable, may issue an order re-

quiring such person to appear at any des-

ignated place to testify or to produce docu-

1	mentary or other evidence. Any failure to
2	obey the order of the court may be pun
3	ished by the court as a contempt of that
4	court.
5	(ii) Additional enforcement.—
6	Sections 102 through 104 of the Revised
7	Statutes of the United States (2 U.S.C
8	192 through 194) shall apply in the case
9	of any failure of any witness to comply
10	with any subpoena or to testify when sum
11	moned under authority of this section.
12	(b) Closed Meetings.—
13	(1) In general.—Meetings of the Commission
14	may be closed to the public under section 10(d) or
15	the Federal Advisory Committee Act (5 U.S.C
16	App.) or other applicable law.
17	(2) Additional authority.—In addition to
18	the authority under paragraph (1), section 10(a)(1)
19	and (3) of the Federal Advisory Committee Act (5
20	U.S.C. App.) shall not apply to any portion of a
21	Commission meeting if the President determines
22	that such portion or portions of that meeting is like
23	ly to disclose matters that could endanger national
