



55 of Oregon's 57 hospitals are now enrolled in the Oregon Patient Safety Commission's voluntary and confidential reporting program for serious adverse events. (The latest member to join the program is Curry General Hospital in Gold Beach.)

These 55 hospitals provide over 99% of inpatient care in Oregon. Participating hospitals report detailed information on adverse events to the Commission in a cooperative effort to improve patient outcomes.

The Patient Safety Reporting Program provides opportunities to highlight emerging patient safety issues in the state, identify best practices, and share confidential information in a risk-free way.
