# ISPO Information System (IIS) Database Progress Report

The International Safeguards Project Office (ISPO) has been using their information management system built by the Information Systems Analysis and Development (ISAD) team at Los Alamos National Laboratory for the past The system handles daily operations, such as travel arrangements, calendars, contact management, and access requests. The system has an electronic library which houses reports, documents, photos, and other material. Another important component is the recruitment module, which is being used to attract highly desirable experts to assist the International Atomic Energy Agency through cost-free expert and junior The ISPO professional officer positions. recruitment office is using the IIS to plan for and manage recruitment trips, tradeshows, and other outreach activities.

In addition to the internal elements of the system, ISPO began testing the financial module in November with several POTAS coordinators participating. The test was expanded to include all contractors in December. The financial module was approved by ISPO in January. Participants have now begun entering their data into the module. Laboratory Coordinators can access the module to view up-to-date financial information for their active and closed tasks. ISPO appreciates the help and patience of all those who participated in the tests.

The next element of the external system to be beta tested is the capsule summary module. This new format will allow interactive input, eliminating the need to contact ISPO to make corrections. Once the Coordinator is satisfied with their summary, they can click on a submit button which notifies ISPO that the summary is ready for review. Coordinators will have access to a report which details the status of each summary: awaiting submission, pending approval, approved, or returned for modification.

The capsule summary module is expected to be ready in time for the April 1, 2008, report.

During the month of February, ISAD developers and ISPO task monitors worked together to finalize the task management module. Once this critical module has been approved, it will undergo beta testing using program coordinators from a variety of organizations. This beta test will give participants the opportunity to provide suggestions and clarify any outstanding issues.
