Notes:

- (1) Amounts include all Federal expenditures to the American Samoa Government including ASCC, ASPA, and the Medical Authority.
- (2) All data are provided by the various agencies unless noted with an "\*". In those cases, the data is taken from Bureau of Census publications.
- (3) FY00 FEMA funding includes \$14,457,427 which was deobligated. This funding is not included in the total shown on this chart as it was an accounting adjustment.
- (4) DOI funding to ASG for FY01 will go up about \$1 million when FWS funding is received.
- (5) USPS data excludes salaries and wages (which is listed under salaries & wages), but includes the cost of transporting the mail beginning with FY2000.
- (6) Payments for Military Cover-overs are listed in the year paid, which is two years later than the applicable tax year.
