Forest Supervisor's Order

EMERGENCY ORDER H-04-08 -- AREA USE RESTRICTION

In Order to Provide for Public Safety

Emergency Order H-04-07 dated July 26, 2004, and signed by the Forest Supervisor, is hereby rescinded.

The threat to public safety due to the Ogden Fire still exists, therefore necessitating a portion of the area remain under area use restriction. Pursuant to Title 36 Code of Federal Regulations 261.50(a) and (b), this area restriction is in effect on the Helena National Forest. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations, and become effective when signed and will remain in effect for one year, or less if rescinded sooner.

All persons are prohibited from going into or being upon all National Forest System Lands administered by the Helena National Forest that are within the Ogden fire area [36 CFR 261.52 (e)]. The area also includes Forest Service lands west of Dalton Mountain Road #329 and lands east of Ogden Mountain Road #1163.


The reason for the closure is to provide for public and firefighter safety due to wildfires in the area; therefore the public is prohibited from use of this area.

Exemptions:

Pursuant to Title 36 CFR 261.50(e), the following are exempt from this order:

1. Any person with a permit authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or fighting force in the performance of an official duty.

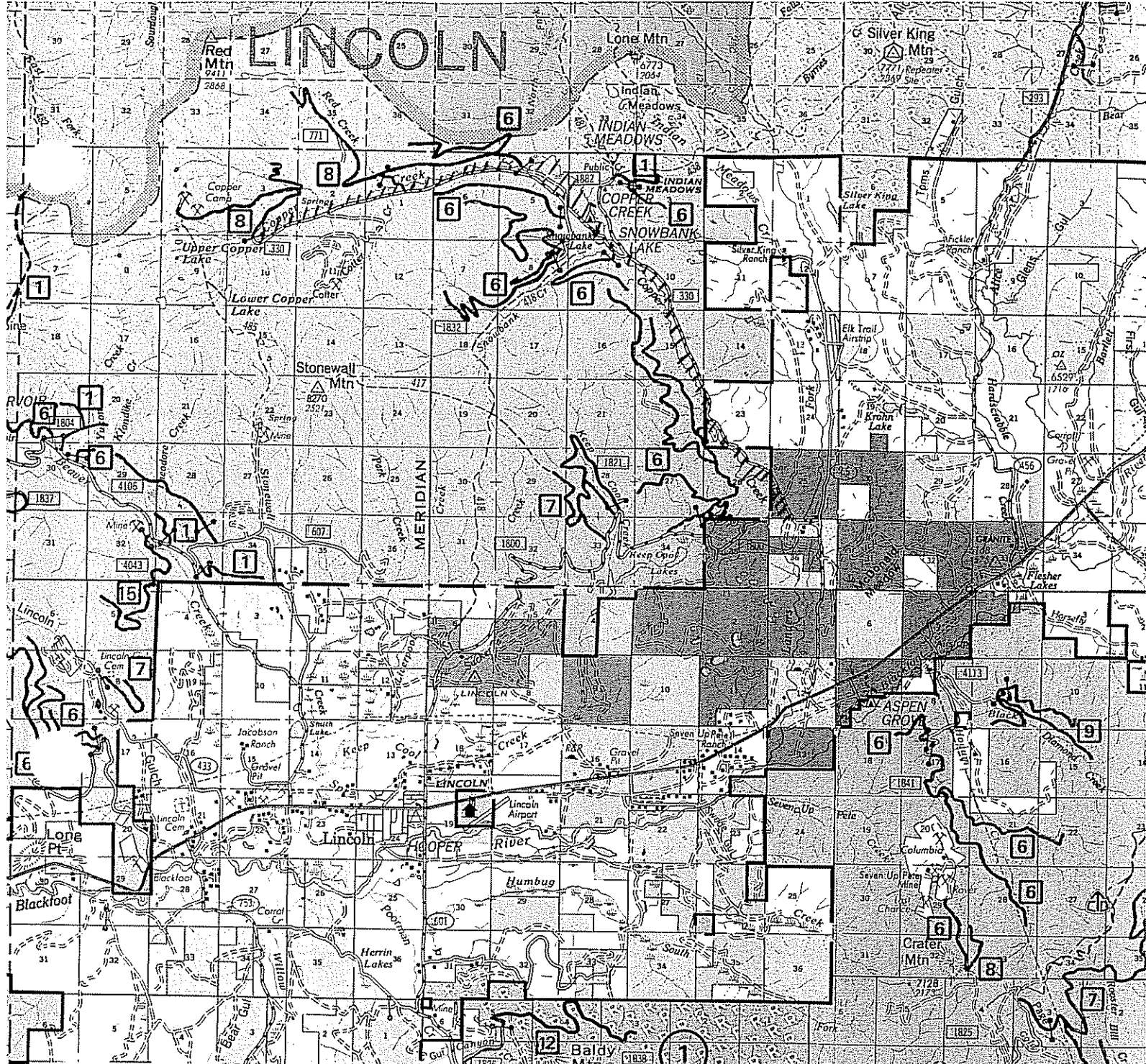

Penalty:

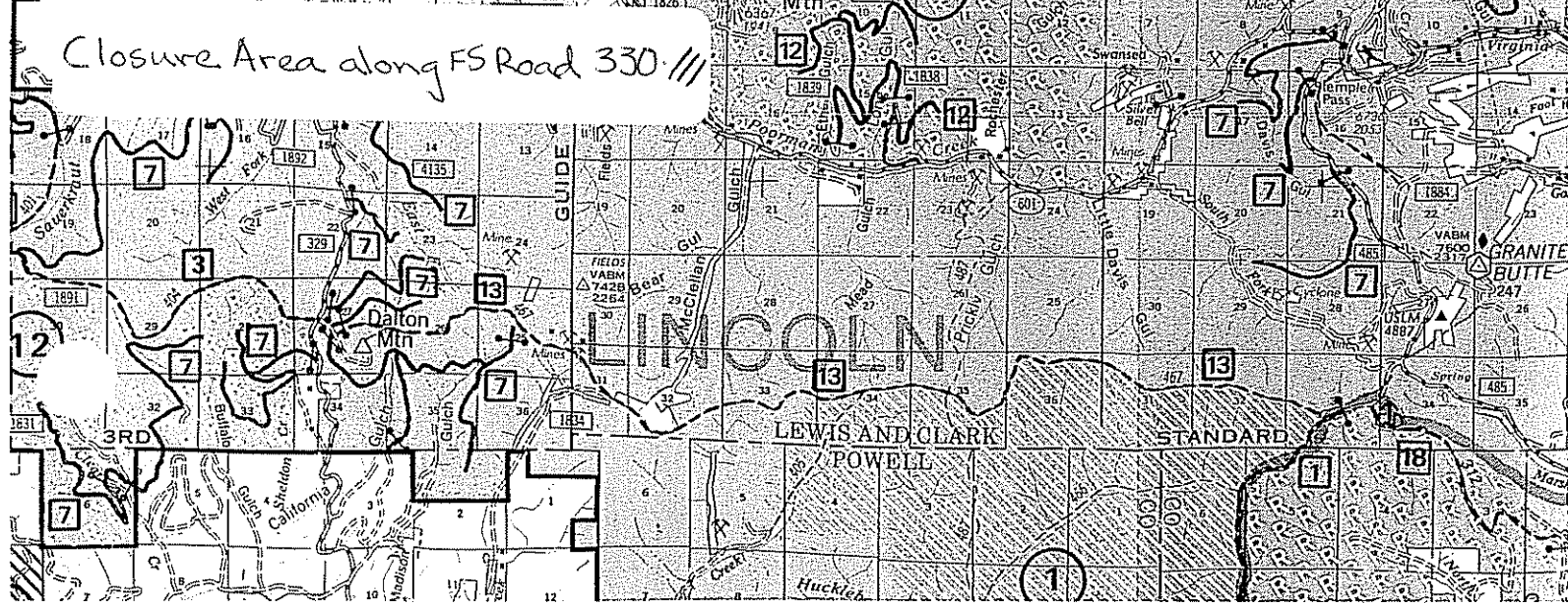
Violations of these prohibitions are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both [16 U.S.C. 551, and 18 U.S.C. 3559 and 3571].
