Forest Supervisor's Order

**EMERGENCY ORDER for USE OF VEHICLES  
NATIONAL FOREST SYSTEM ROADS and TRAILS  
Lower Keep Cool Lake Area Closure/Lincoln Ranger District**

Pursuant to Title 36 Code of Federal Regulations 261.50(a) and (b), the following restriction is in effect on the Helena National Forest. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations, become effective when signed and remain in effect for one year or until rescinded.

**36CFR 261.54(a) – National Forest System roads.**

**When provided by an order, the following are prohibited: using any type of vehicle prohibited by the order. [Title 36, 261.54(a)]**

**36CFR 261.55(b) – Forest Development Trails.**

**When provided by an order, the following are prohibited: using any type of vehicle prohibited by the order. [Title 36, 261.55(b)]**

For the purpose of this order it is prohibited to operate a motor vehicle on the Helena National Forest System roads and trails depicted in the map, Attachment A, hereby made part of this order. The reason for this order is to provide for resource protection, specifically wildlife, wetlands and soil. The legal description for this closure is T15N, R8W south of FS Road 1800 in section 33; south of FS Road 1800 in the southwest quarter of section 34; and, T14N, R8W south of FS Road 1800 in section 4. The closure does not include FS Road 1800.

Definitions: Vehicles (including cars, trucks, all-terrain vehicles which include 3-wheelers, 4-wheelers, 6-wheelers and motorcycles) means any device in upon, or by which any person or property may be transported, including any frame, chassis, or body of any motor vehicle.

**Exemptions:**

Pursuant to Title 36 CFR 261.50(e), the following are exempt from this order:

1. Any person with a permit authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or fighting force in the performance of an official duty.

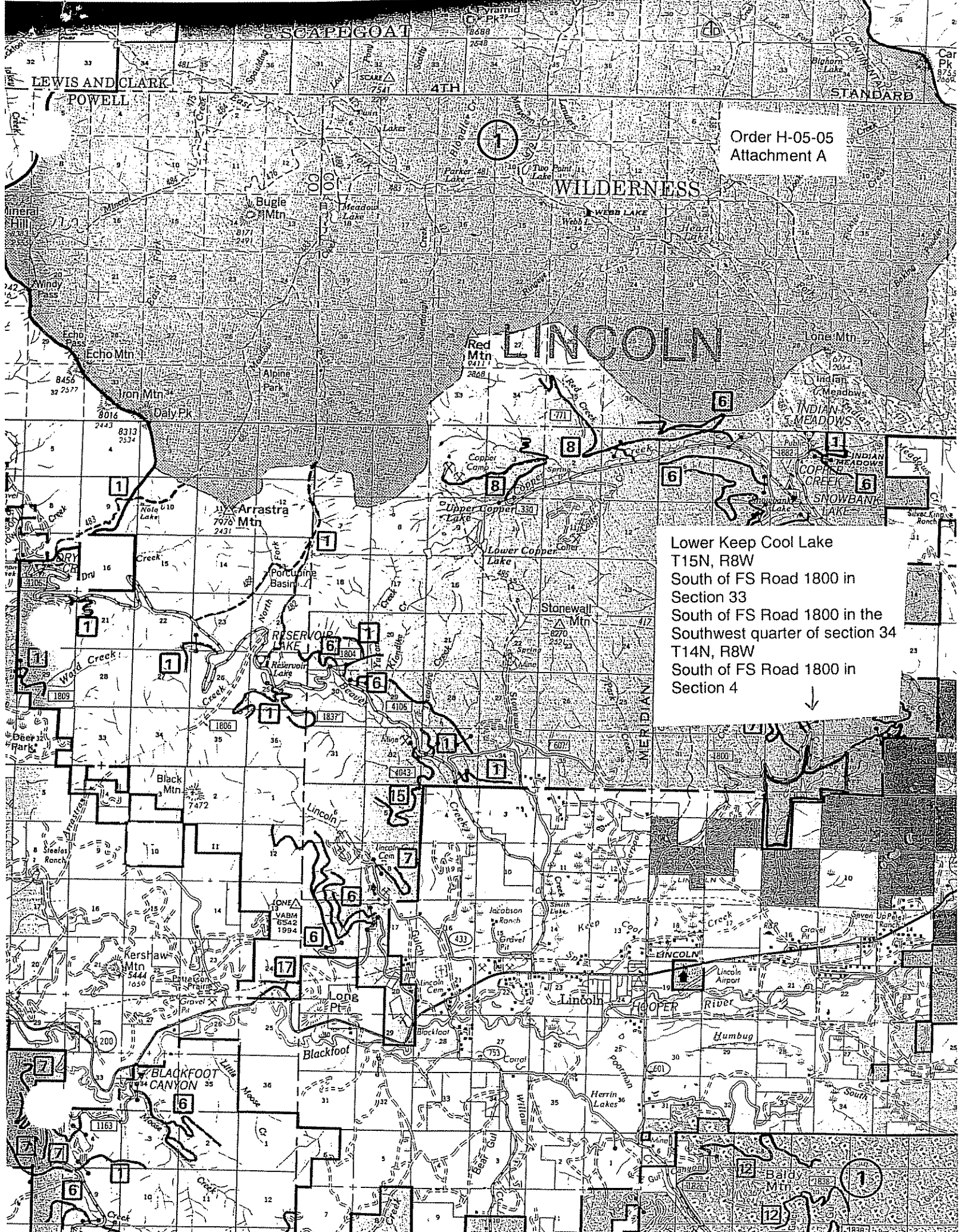

Violations of these prohibitions are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both [16 U.S.C. 551, and 18 U.S.C. 3559 d 3571].
