Forest Supervisor's Order

EMERGENCY ORDER for OCCUPANCY AND USE
NATIONAL FOREST SYSTEM LANDS
Park Lake Campground

Pursuant to Title 36 Code of Federal Regulations 261.50 (a) and (b), the following restrictions are in effect on the Helena National Forest. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations, and become effective and become effective when signed and will remain in effect until rescinded.

36 CFR 261.52 – Fire:

Fire [Title 36, 261.52 (a)]

For the purpose of this order, building, maintaining, attending or using a fire, campfire, or stove fire is prohibited yearlong on National Forest lands within a quarter (.25) mile of the high water level of Park Lake located in section 13, T8N, R5W depicted in Attachment "A" hereby made part of this order, Except for persons legally occupying a designated campsite within Park Lake Campground.

36 CFR 261.58 – Occupancy And Use:

Camping [Title 36, 261.58 (e)]


For the purpose of this order camping is prohibited yearlong on National Forest lands within a quarter (.25) mile of the high water level of Park Lake, except for persons legally occupying a designated campsite within Park Lake Campground.

Exemptions:

Pursuant to Title 36 CFR 261.50 (e) the following are exempt from this order:

- Any person with a permit authorizing the otherwise prohibited act or omission.
- Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.
- Persons legally occupying a designated campsite within Park Lake Campground.

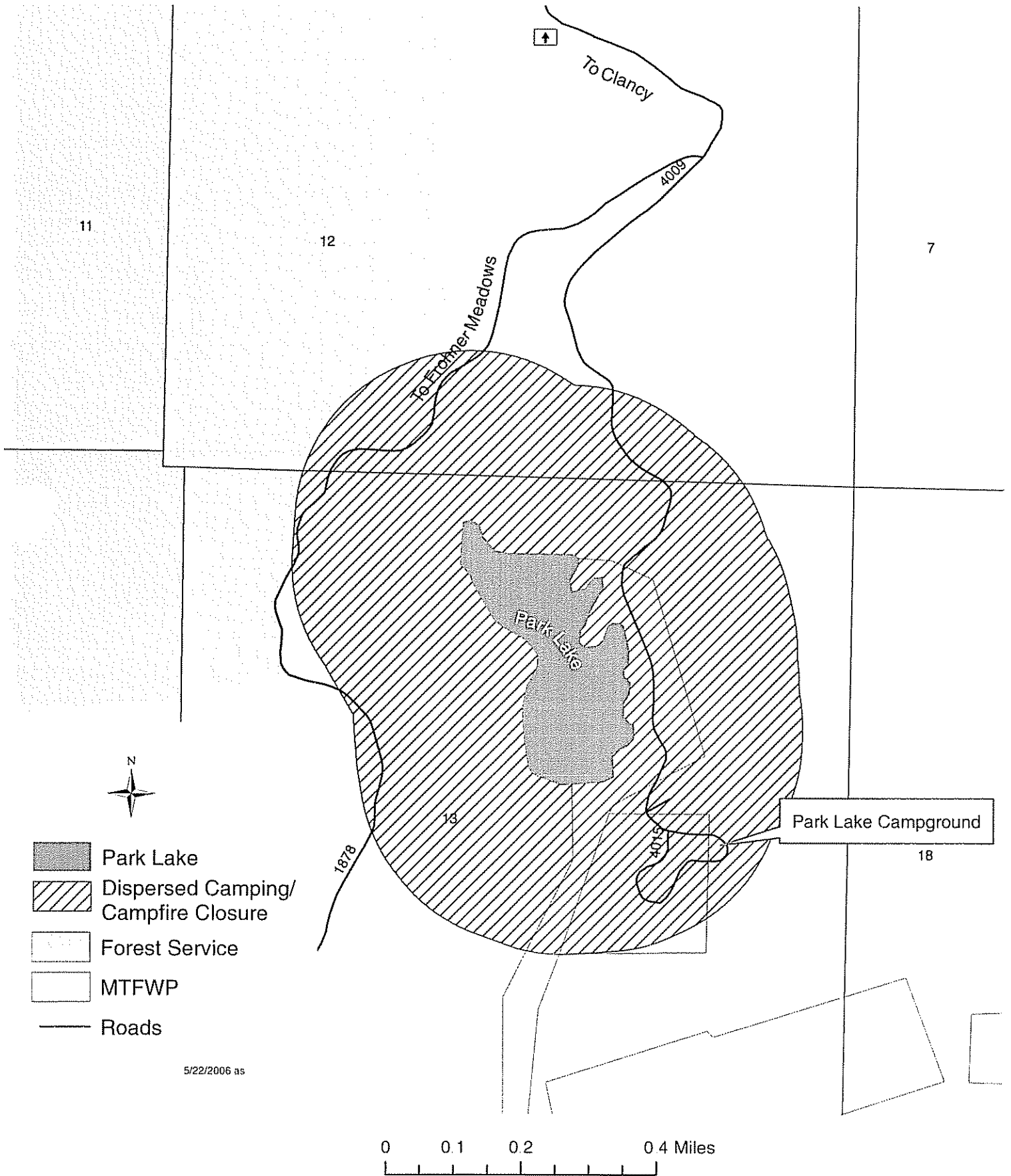
Penalty:

Violations of these Prohibitions are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months or both. [16 U.S.C. 551, and 18 U.S.C. 3559 and 3571]
