National Forest System roads

Pursuant to Title 36 Code of Federal Regulations 261.50 (a) and (b), the following restrictions are in effect on the Helena National Forest. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations, and become effective when signed and will remain in effect until March 1st, 2007, or until rescinded.

36 CFR 261.54 - National Forest System roads:

Using any type of vehicle prohibited by the order. [Title 36, 261.54 (a)] Use of any type of traffic prohibited by the order. [Title 36, 261.54 (b)]

For the purpose of this order it is prohibited for any persons to operate an off-highway vehicle (snowmobile) from 12 a.m. Monday until 12 a.m. Saturday on Copper Creek Road #330 from the Landers Fork Bridge T15N R8W S36 to the section line of T15N R8W S5. It is also prohibited for any persons to use this road for non-motorized activities from 12 a.m. Monday until 12 a.m. Saturday.

For the purpose of this order it is prohibited for any persons to operate a motorized vehicle (wheeled vehicles and snowmobiles) from 12 a.m. Monday until 12 a.m. Saturday on Road #1832 to Royal Park and Road #1883 beginning in T15N R8W S5. It is also prohibited for any persons to use these roads for non-motorized activities from 12 a.m. Monday until 12 a.m. Saturday.

For the purpose of this order it is prohibited for any persons to operate a wheeled vehicle from 12 a.m. Saturday until 12 a.m. Monday on Copper Creek Road #330 from Landers Fork Bridge north beginning in T15N R8W S36 and on Road #1832 to Royal Park and Road #1883 beginning in T15N R8W S5.

Exemptions:

Pursuant to Title 36 CFR 261.50 (e), the following are exempt from this order:

- 1. Any person with a permit authorizing the otherwise prohibited act or omission or associated with the Snow Talon Salvage Contract.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fighting force in the performance of an official duty.

Penalty:
