## **MEMORANDUM**

**Subject:** Resource Advisory Committee (RAC) Meeting(s) for 2007

As you may be aware, Secure Rural Schools and Community Schools Self-Determination Act of 2000 was extended for one year by Congress and was approved by the President. According to Section 203 of the Act, "Not later than...and each September 30 thereafter for each succeeding fiscal year...each resource advisory committee (RAC) shall submit to the Secretary concerned a description of any projects that the resource advisory committee proposes the Secretary undertake using any project funds reserved by eligible counties.....". In order to meet the deadline to have project recommendations from the RAC, we have developed a schedule to help us accomplish this for 2007 (see Attachment 1).

We are scheduling a RAC proposal meeting on **August 16, 2007** to review and make recommendations on proposed projects. We have also identified August 21 as a backup date if we need it. We have purposely avoided September as Salem District staff are planning on holding a number of open houses surrounding the Western Oregon Plan revision effort during that month.
