PATIENT SELECTION CRITERIA

Include if **ALL** the following criteria are met:

- At least two **face-to-face office visits** with the physician, physicians' assistant, or nurse practitioner during the sampling period with a **documented diagnosis** of coronary artery disease (CAD)
- Is **18 years or older** at the beginning of the sampling period

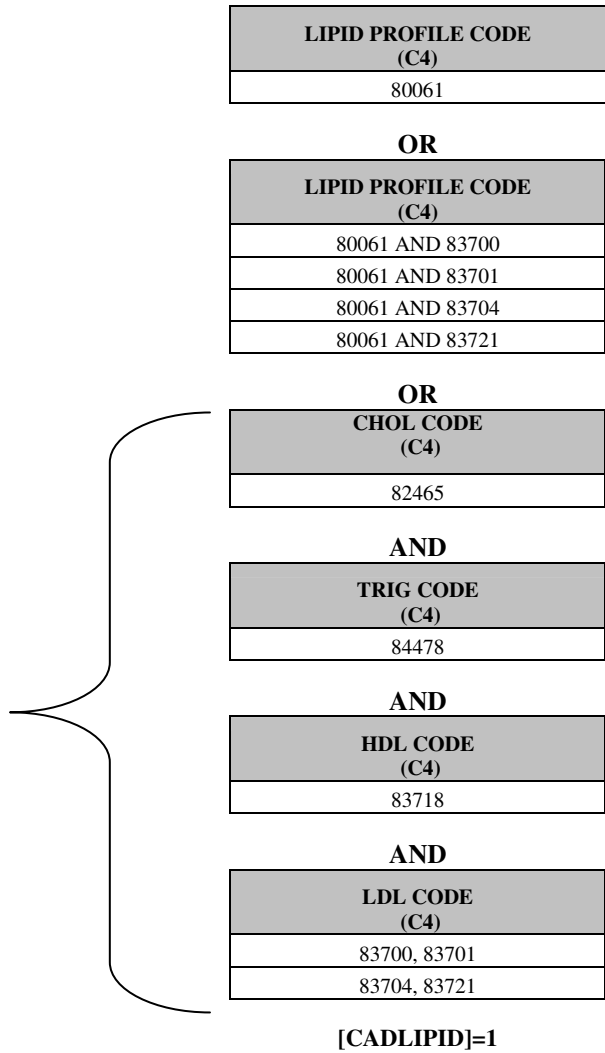
