Dear Mr. Lane:

The New Mexico Department of Transportation (NMDOT), formerly New Mexico Highway and Transportation Department's (NMSHTD), hereby resubmits the application for small MS4, due on April 01, 2007.

NMDOT submitted a small MS4 application for District 3 on February 21, 2003; the EPA did not issue a permit. The NMDOT has sent annual reports to the EPA since April 01, 2004, following up the commitment to fulfill the goals set forth in the proposed six Best Management Practices (BMPs). NMDOT has not yet received a response from EPA.
