To Whom It May Concern:

Submitted herewith is a summary of the New Mexico Department of Transportation – District Five (NMDOT-D5) efforts in completing activities related to the referenced matter.


In 2007, the NMDOT-D5 expended approximately \$9,700 for roadway sweeping operations; and \$16,000 litter pickup; and \$2,500 in structure cleaning performed by NMDOT-D5 in the Farmington Metropolitan Area.

In addition, NMDOT-D5 maintains an active maintenance agreement with the City of Farmington (COF) in which the COF completes routine roadway sweeping of NMDOT-D5 roadways within the corporate limits of Farmington. This routine work totals 53 lane miles of roadway sweeping completed once a month during the months of April – October in 2007. Also, the COF has completed a public awareness campaign along NMDOT-D5 maintained roadways advising the public of the results of dumping material into storm drain inlets. The NMDOT-D5 will provide support to the COF in this effort by paying for the maintenance of warning placards placed on storm drain inlets along NMDOT-D5 roadways.

NMDOT-D5 consistently looks for ways to improve operations and is currently evaluating opportunities for expanding litter pick-up operations through partnerships with the COF, and initiating a public awareness campaign by paying for the broadcast of public service announcements (PSA) on local radio stations advising the public of the results of dumping materials in storm drain inlets.

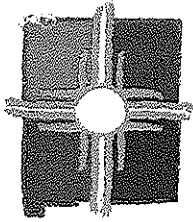


