**FEDERAL OFFICIALS TO BE ON DUTY ON
ELECTION DAY TO RECEIVE CITIZEN COMPLAINTS**

United States Attorney Colm F. Connolly announced today that Leonard Stark, an Assistant United States Attorney in the District of Delaware, will lead the efforts of his Office in the connection with the Justice Department's nationwide Election Day Program for the upcoming November 7, 2006 general elections. AUSA Stark has been appointed to serve as the District Election Officer for the District of Delaware, and in that capacity is responsible for overseeing the District's handling of complaints of election fraud and voting rights abuses in consultation with Justice Department Headquarters.

On October 8, 2002, then-Attorney General John Ashcroft established a Department-wide Ballot Access and Voting Integrity Initiative. The goals of this Initiative are to increase the Department's ability to deter election fraud and discrimination at the polls and to prosecute these offenses whenever and wherever they occur – to make voting easier and cheating harder. Both goals are equally important. It is imperative that in pursuing voter integrity, ballot access is not in any way diminished or harmed.

The Department's long-standing Election Day Program furthers the goals of the Initiative. The Program also is intended to ensure public confidence in the integrity of the election process by

providing local points of contact within the Department where the public can report possible election fraud and voting rights violations while the polls are open on election day. The franchise is the cornerstone of American democracy. We all must ensure that those who are entitled to the franchise exercise it, while those who seek to corrupt it are brought to justice.

In order to respond to complaints of election fraud or voting rights abuses on November 7, 2006, and to ensure that such complaints are directed to the appropriate authorities, USA Connolly stated that Assistant United States Attorney/DEO Stark will be on duty in this District while the polls are open between 7 a.m. and 8 p.m. AUSA Stark can be reached by the public at the following telephone numbers: (302) 573-6277 x106 and (302) 893-5213.

The FBI will also have Special Agents available in each field office and resident agency in this District to receive allegations of election fraud and other election abuses. The FBI can be reached by the public at (302) 658-4391.

United States Attorney Connolly said, "Election fraud and voting rights abuses dilute the worth of votes honestly cast. They also corrupt the essence of our representative form of government. As crimes against both the individual and the government, they will be dealt with promptly and aggressively. Anyone who has information suggesting electoral corruption or voting rights abuses should make that information available immediately to my Office, the FBI, or the Civil Rights Division."
