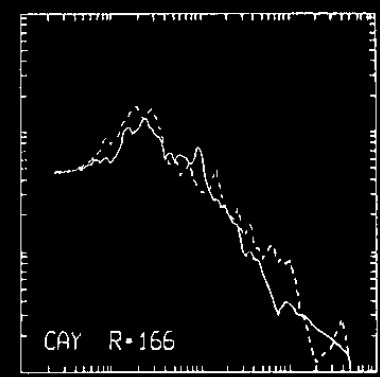
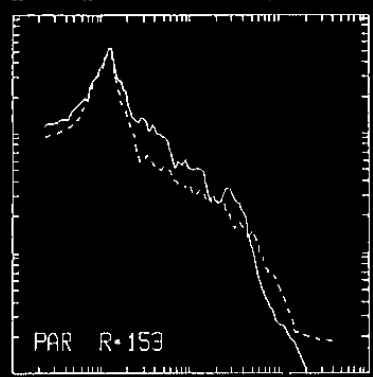
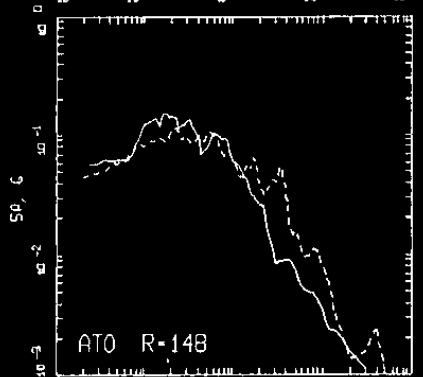
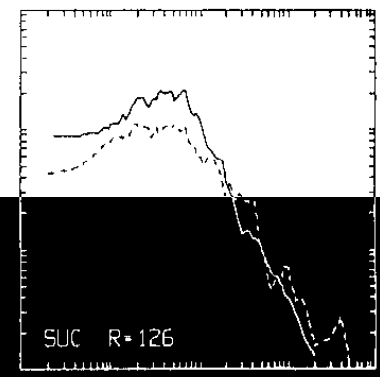
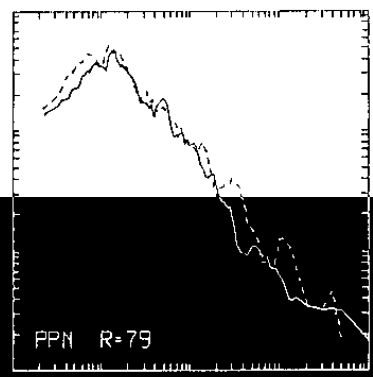
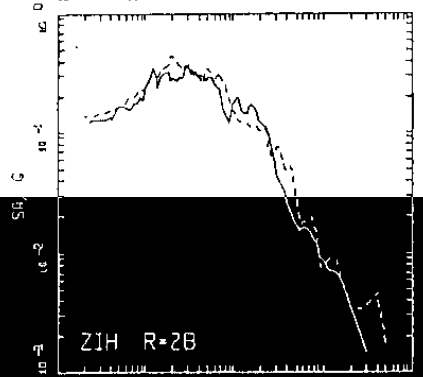
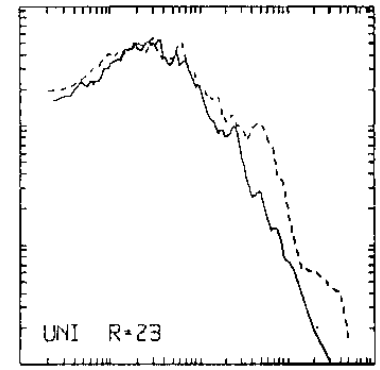
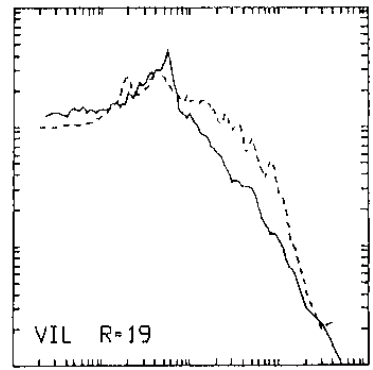
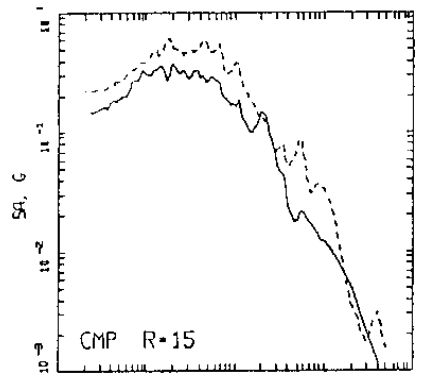


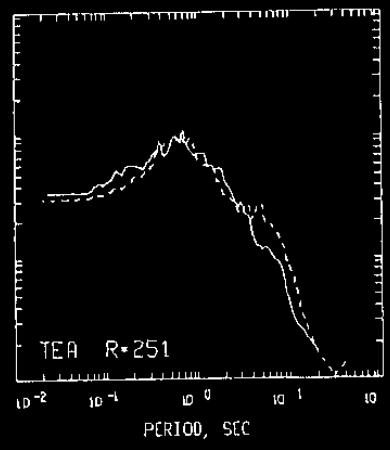
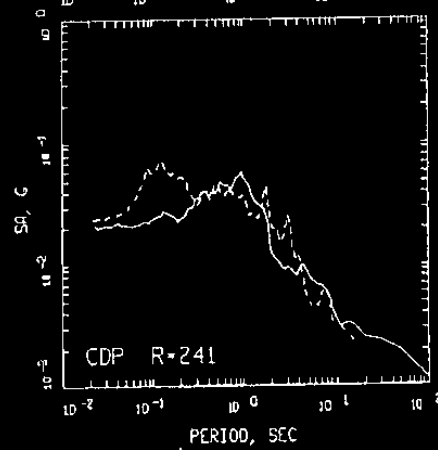
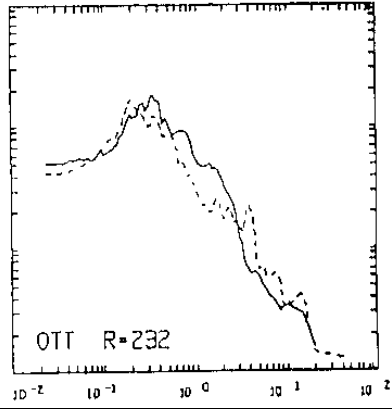
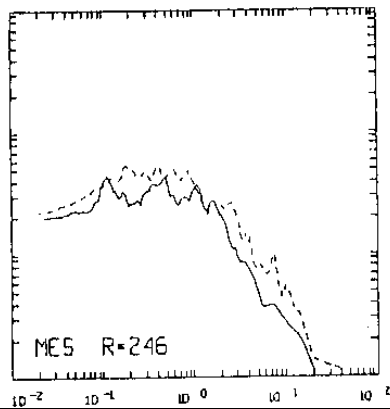
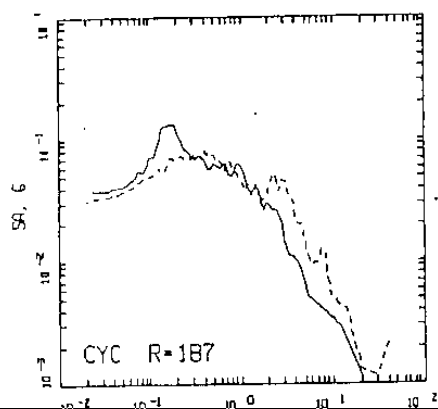
Model Validation

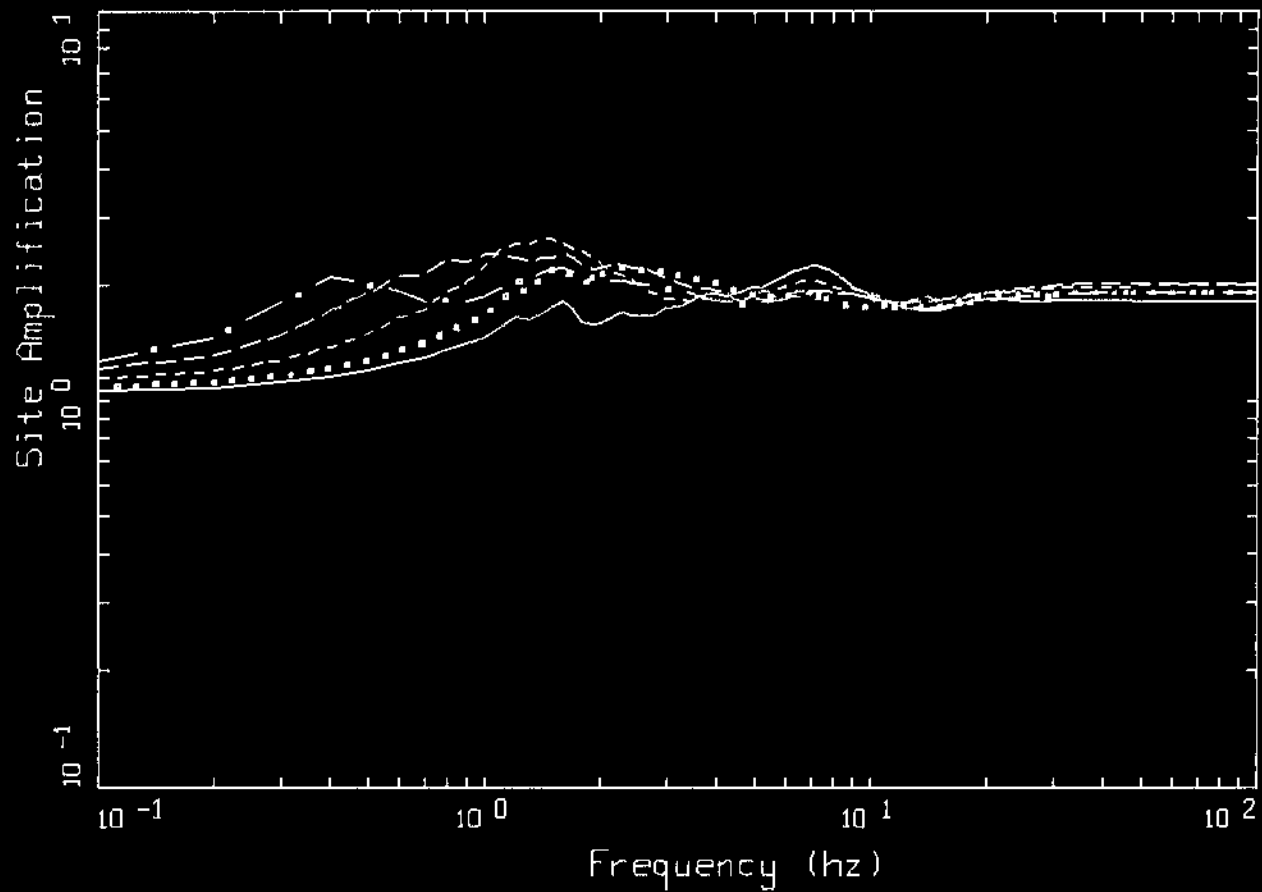


Cascadia Finite-Fault Model

- M 8.0, 8.5, 9.0
- Fault lengths = 150, 450, and 1,100 km
- Fault Width = 90 km
- Dip Angle = 9°
- 16 Site Locations (Center limb, South limb)
- Rock (Columbia River Basalt), Soil site Conditions
- $Q(f) = 380f^{0.39}$ (Atkinson, 1995)
- Crustal Model (Trehu et al., 1994; Cohee et al., 1991; Ludwin et al., 1991)



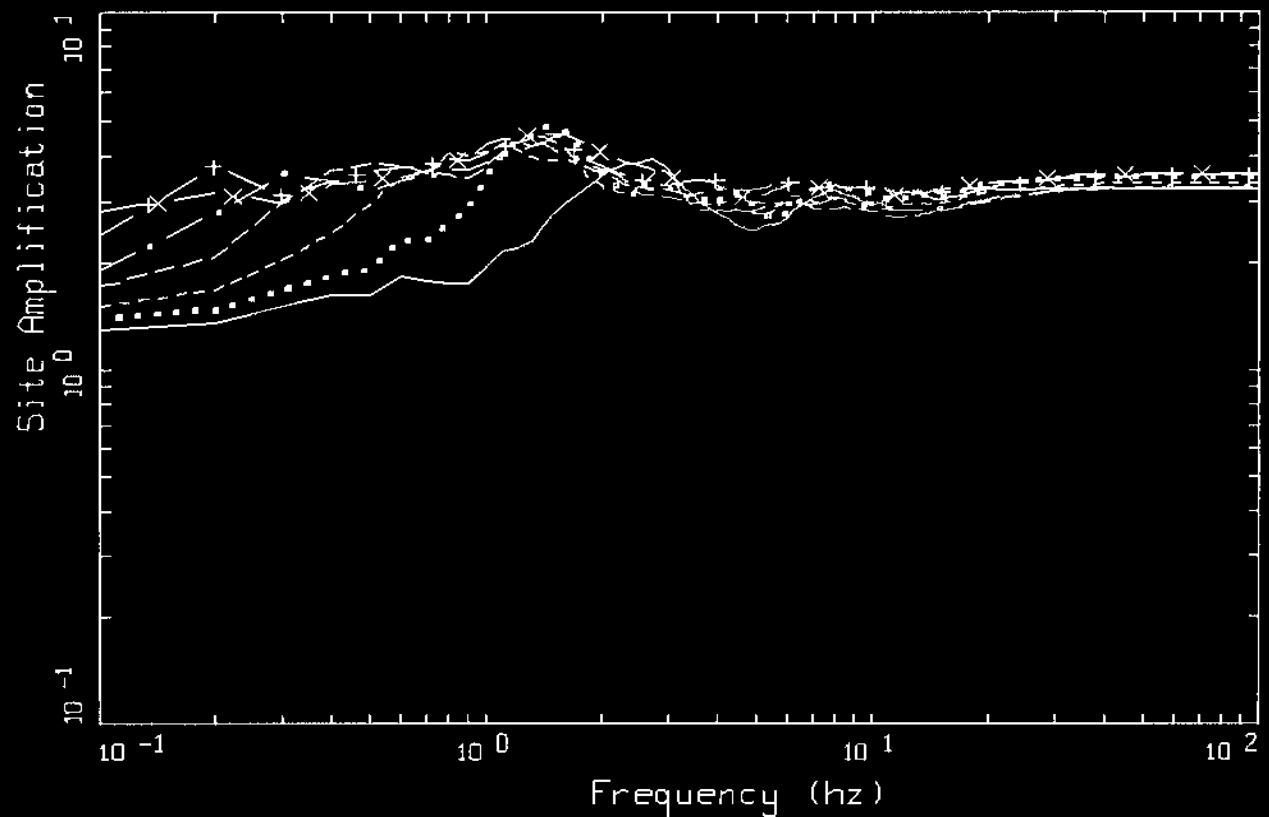




NEHRP C, 400 M/SEC, PR

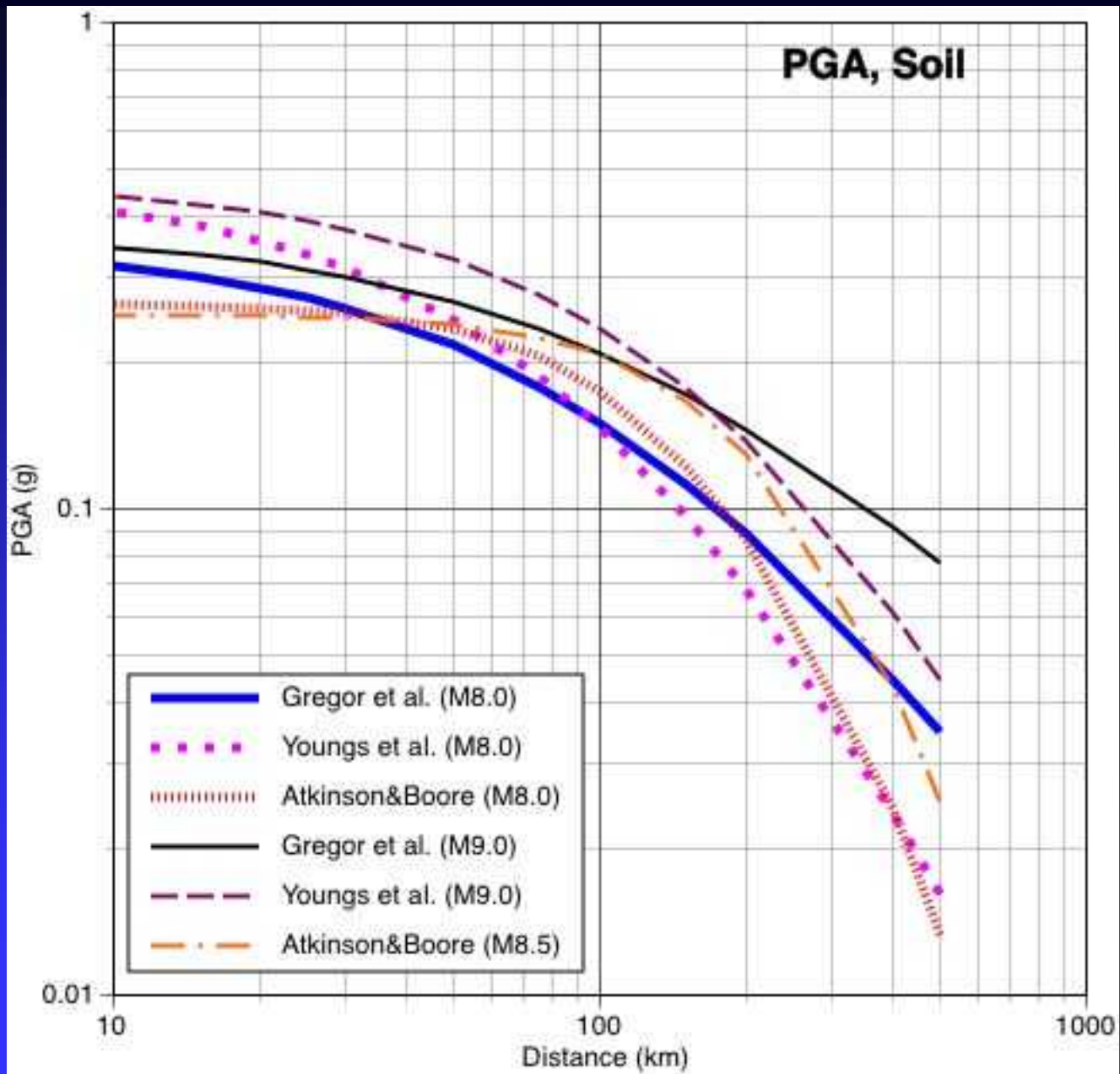


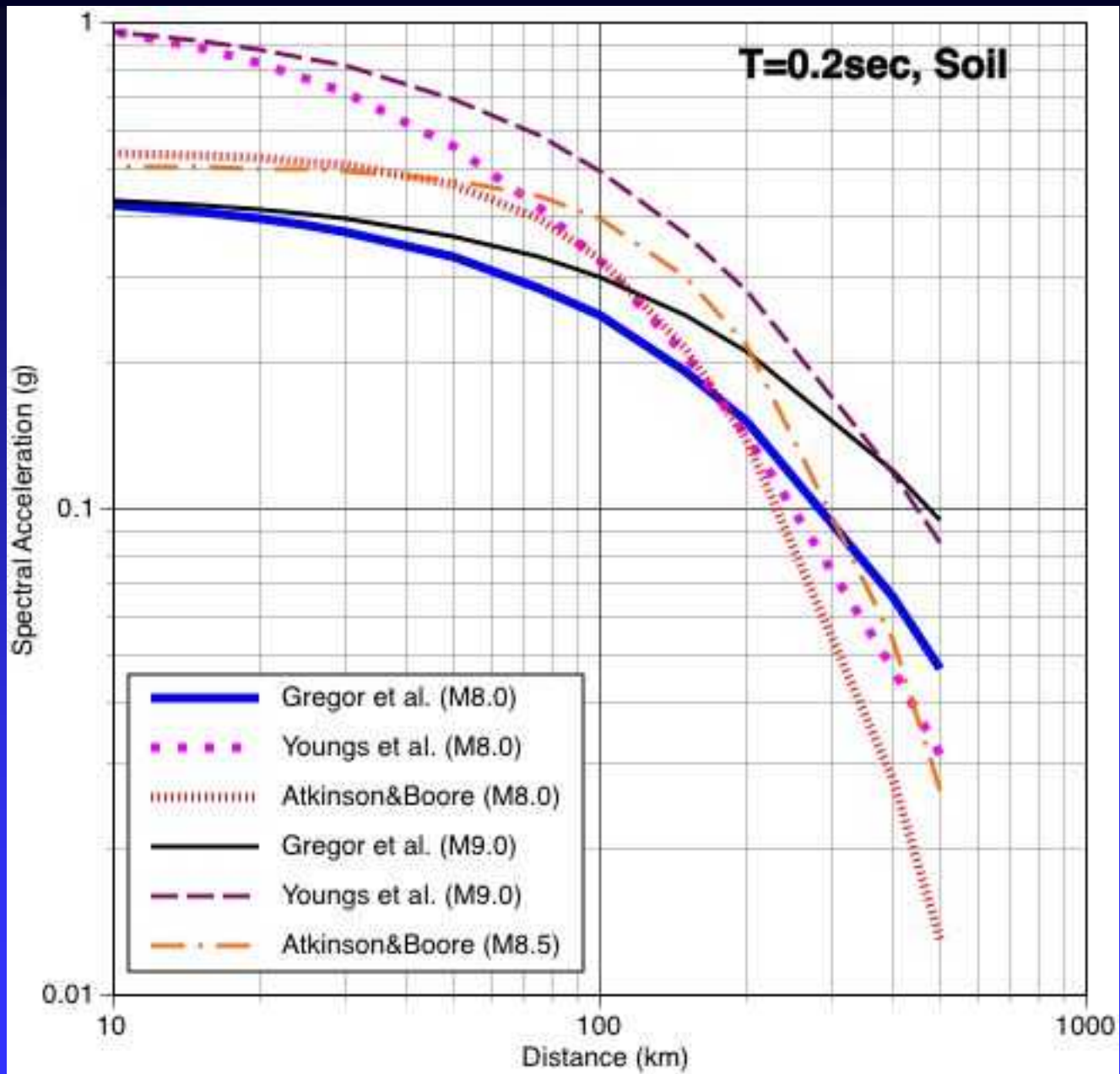


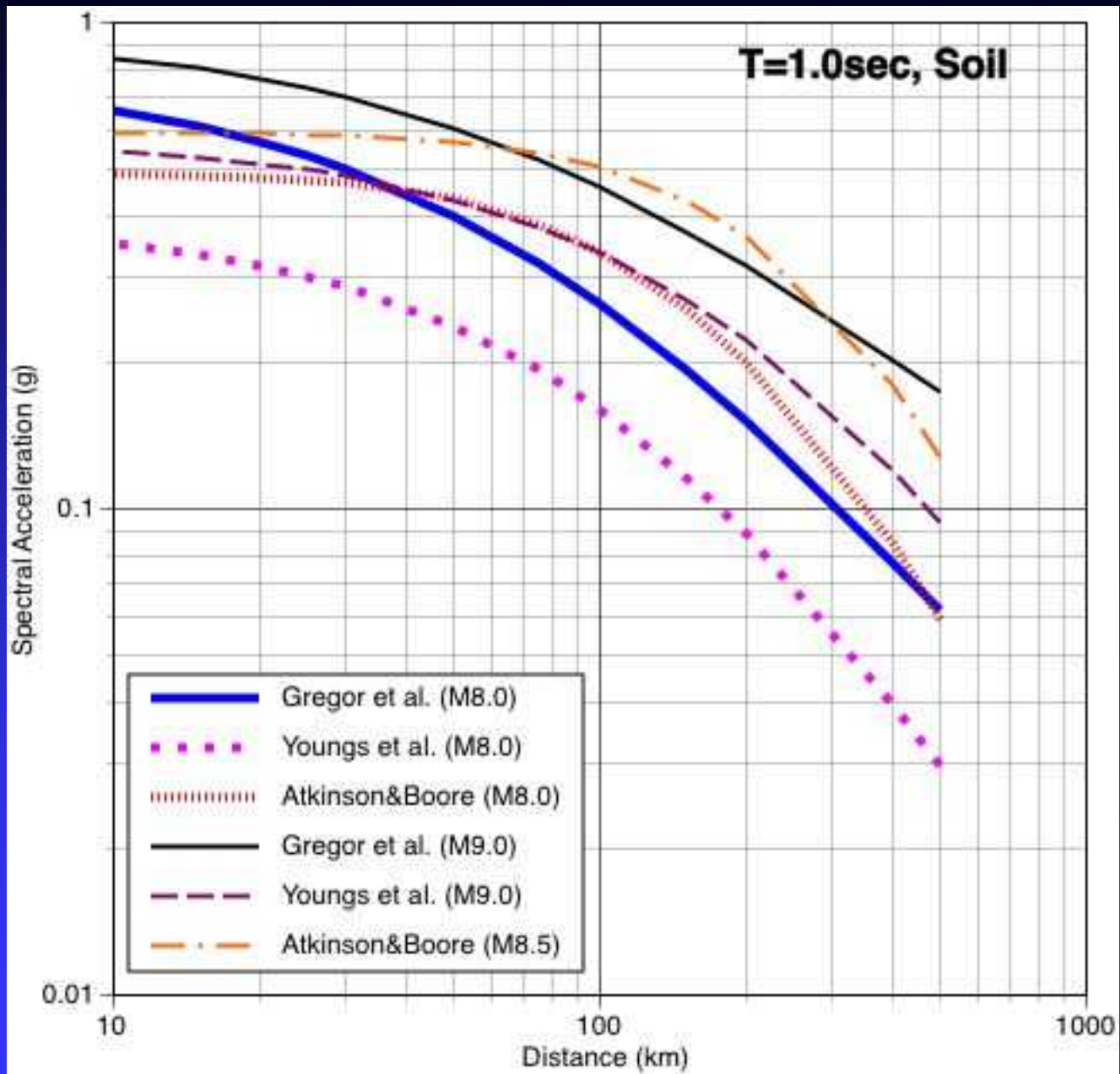


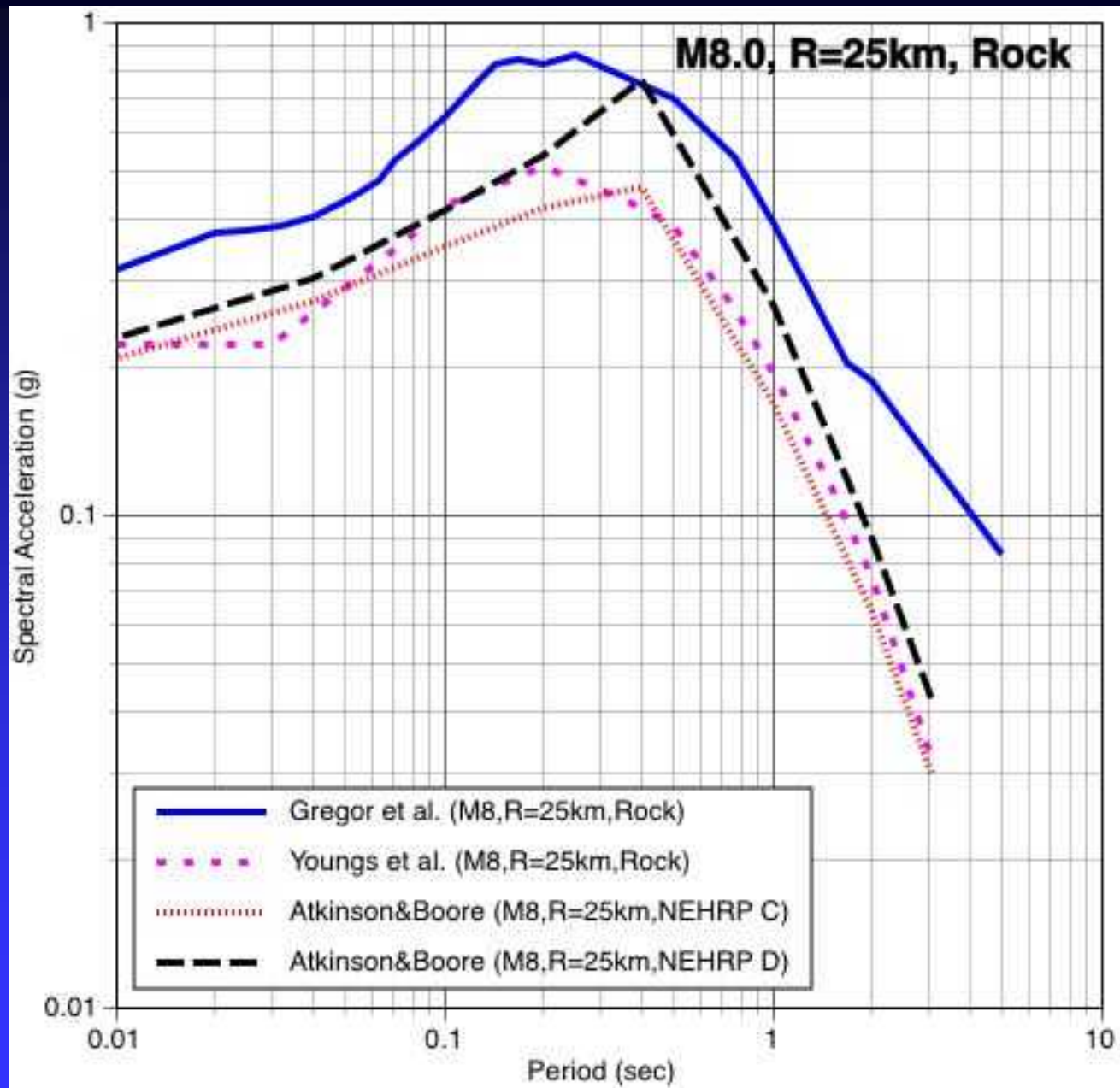


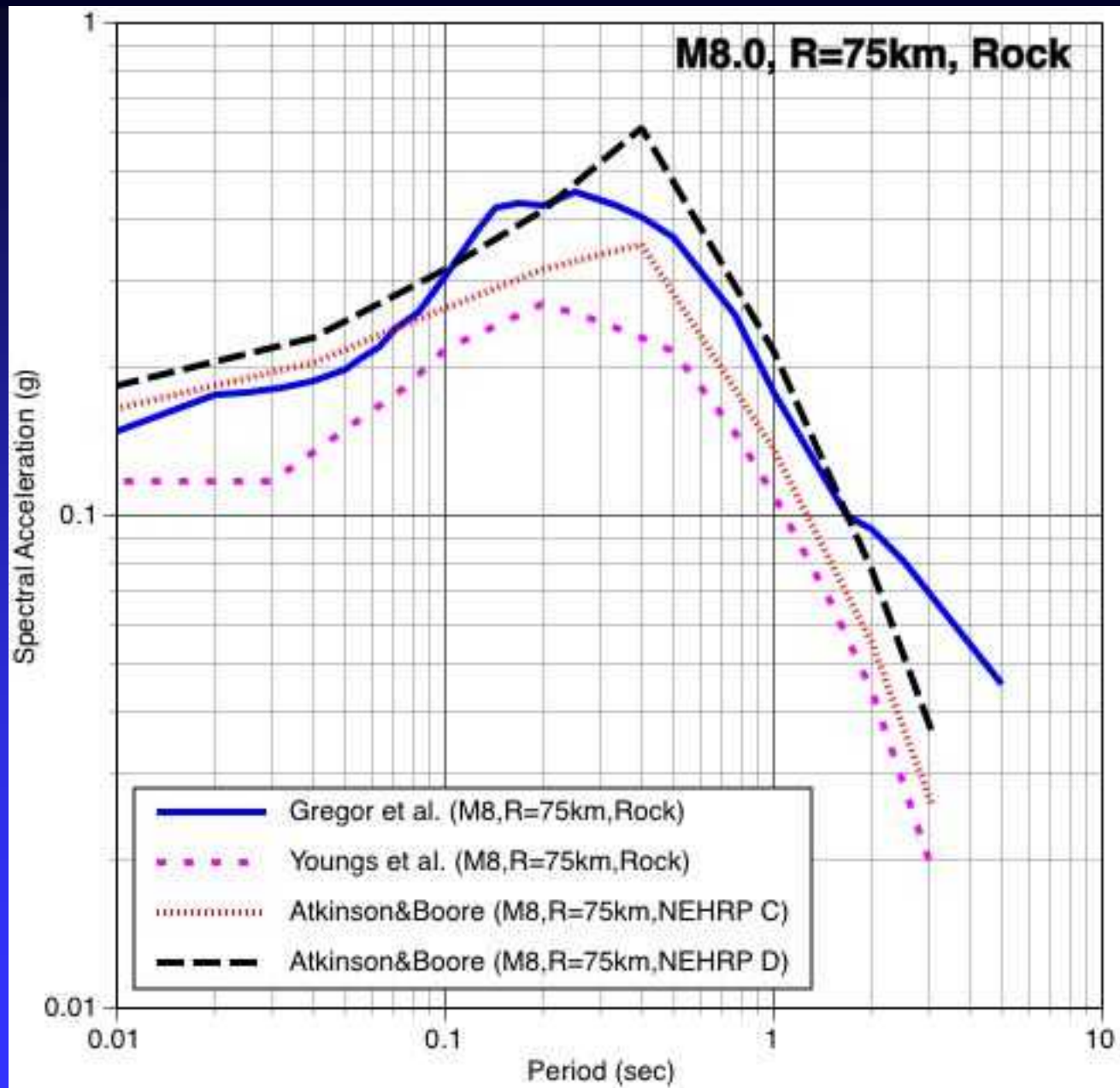


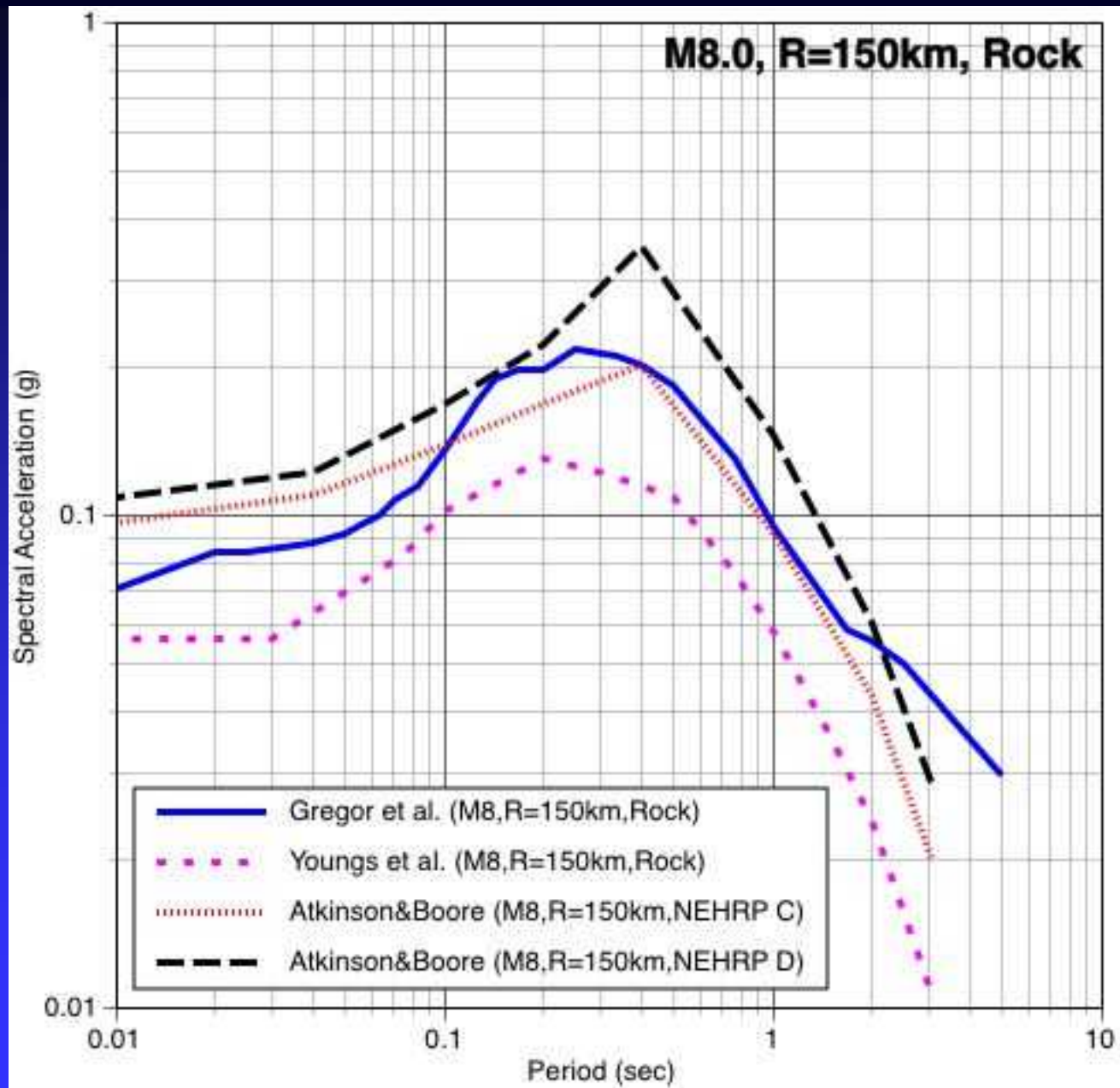


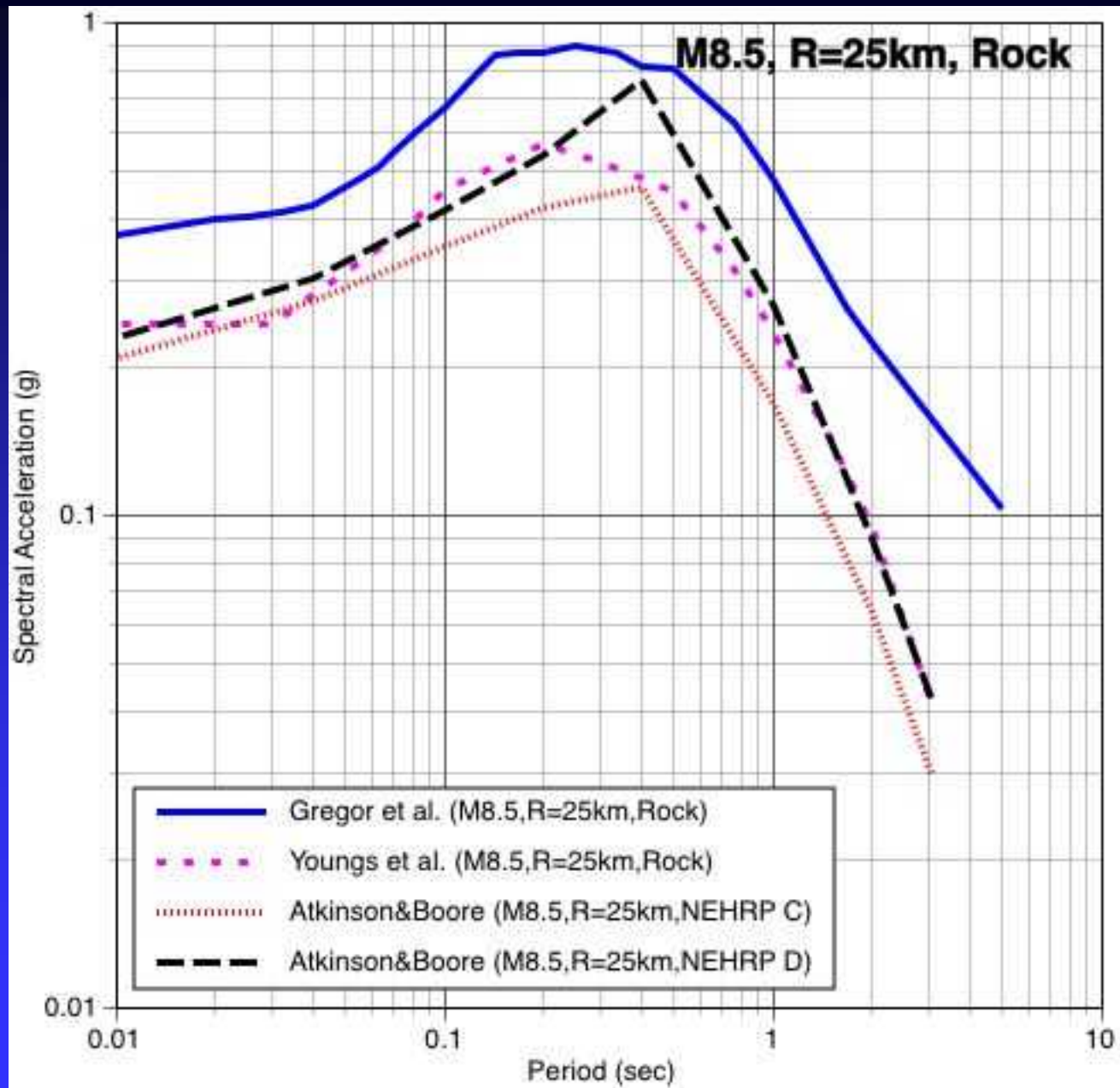


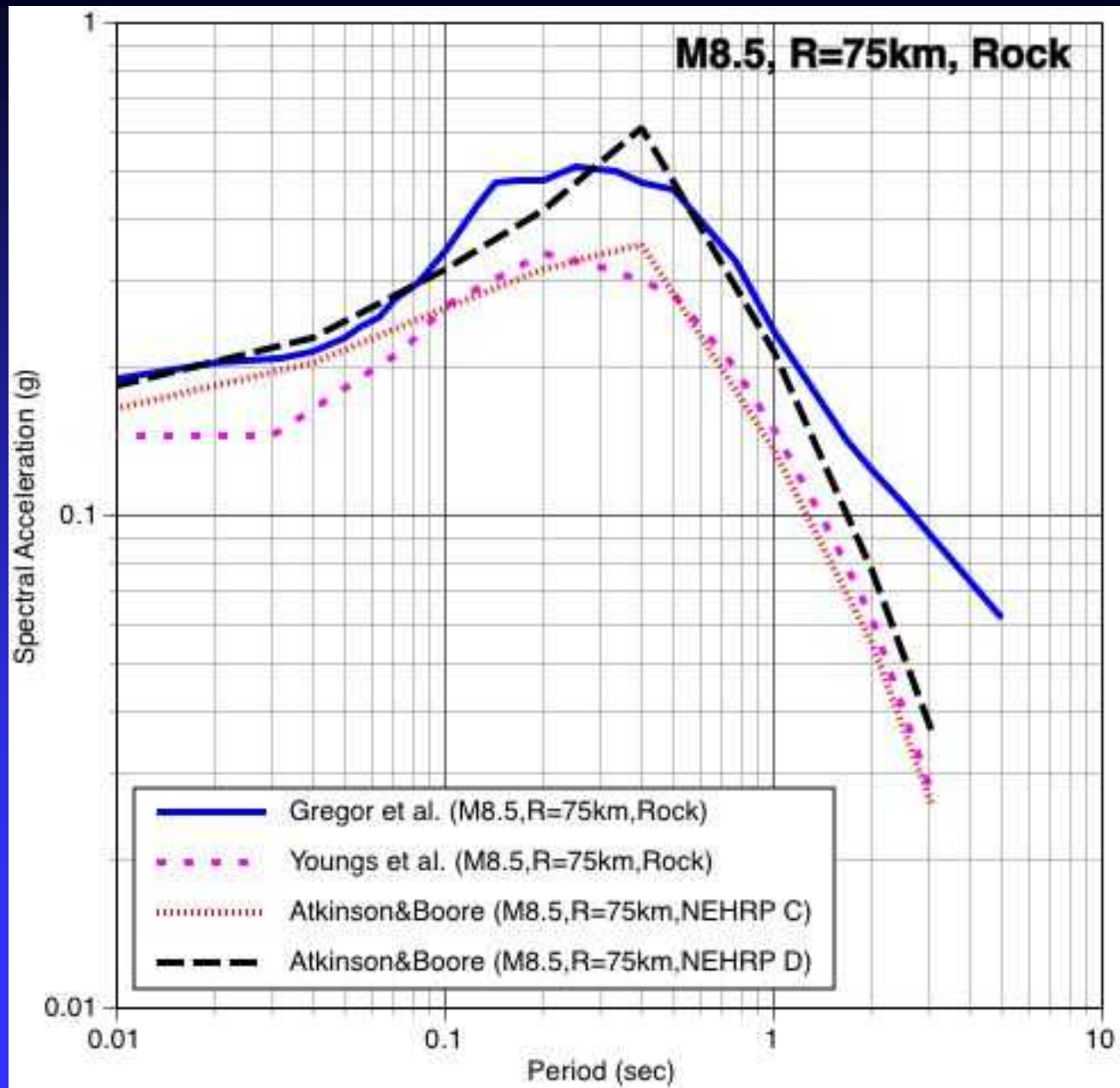


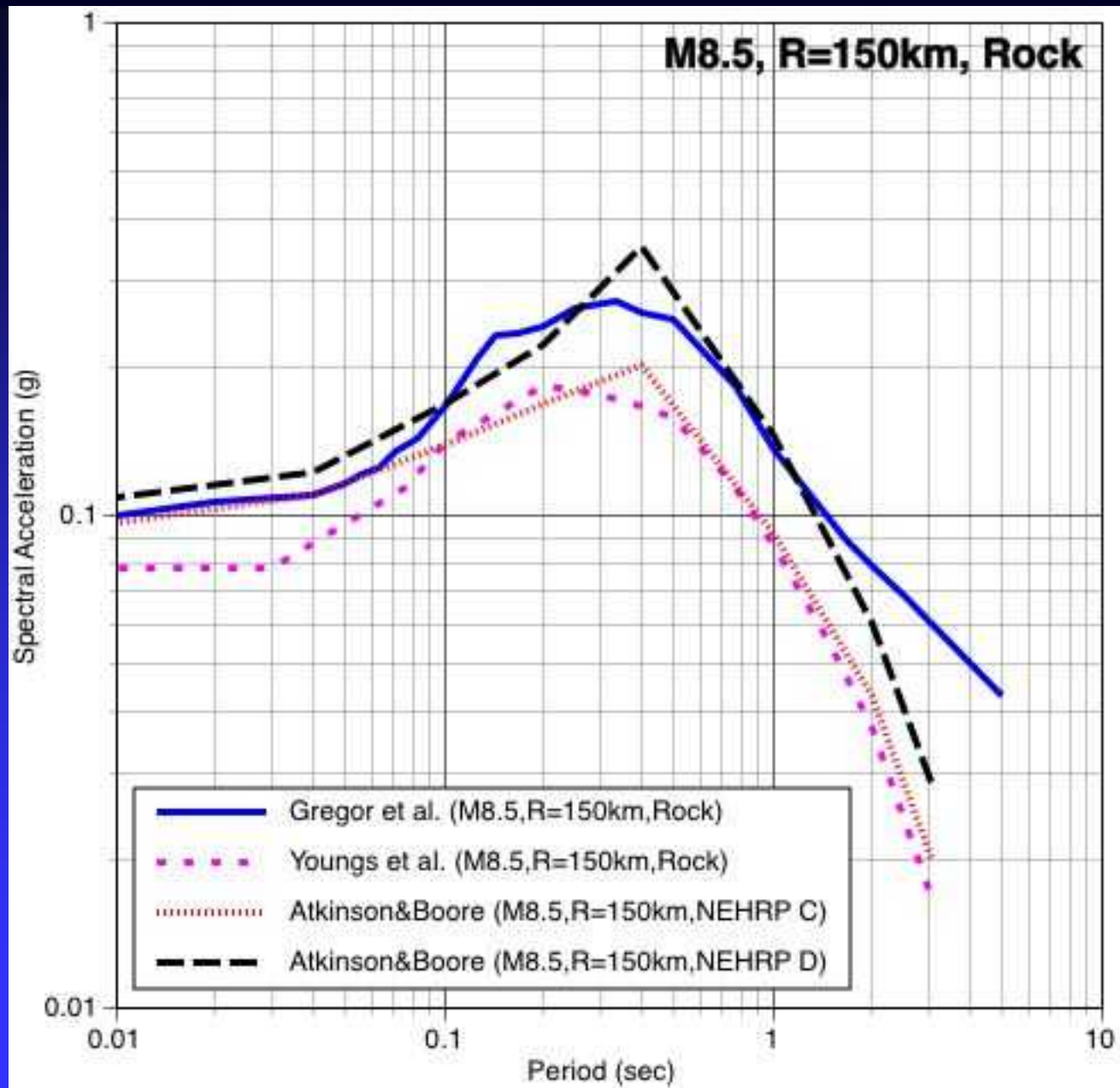


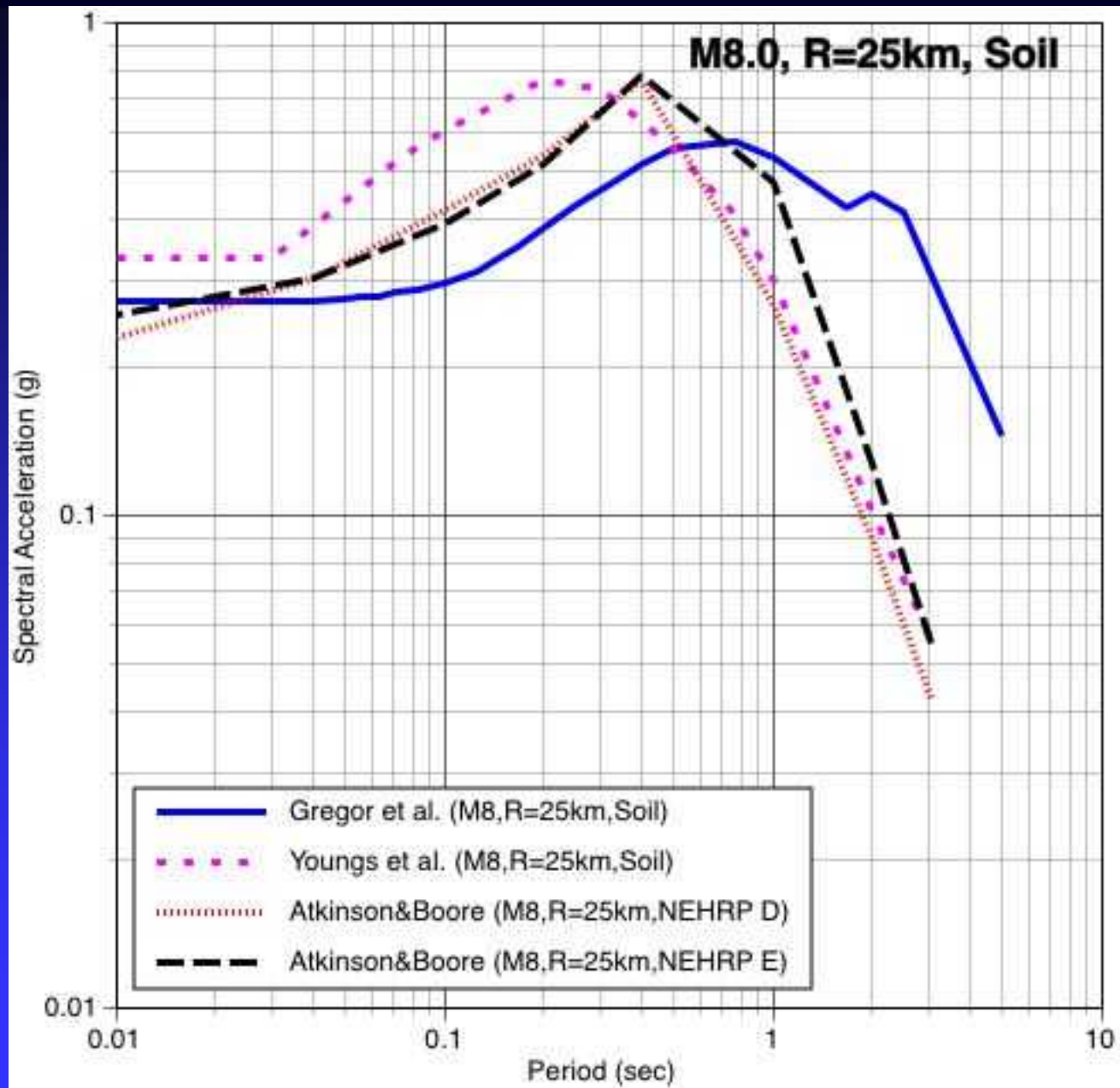


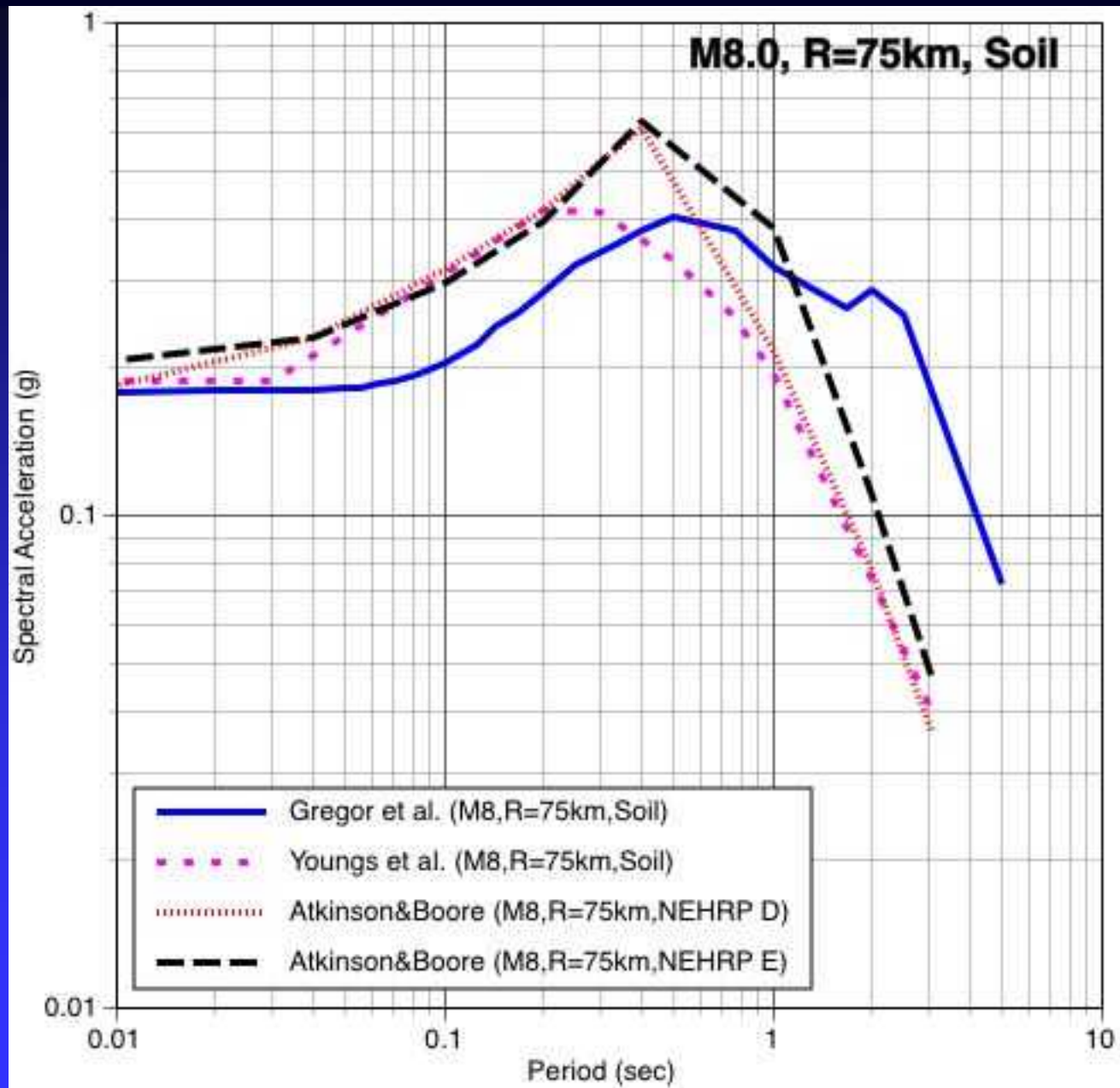


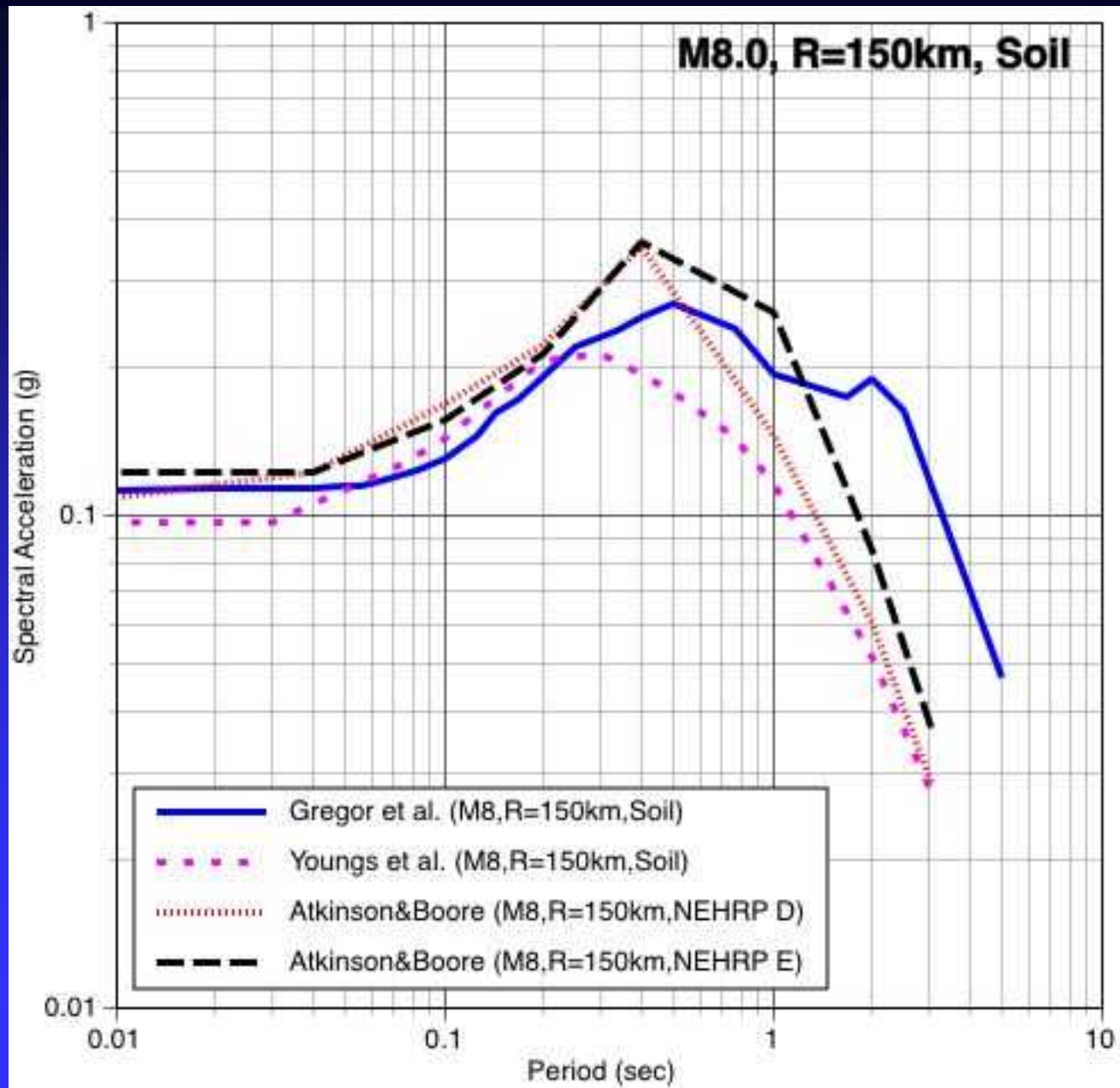


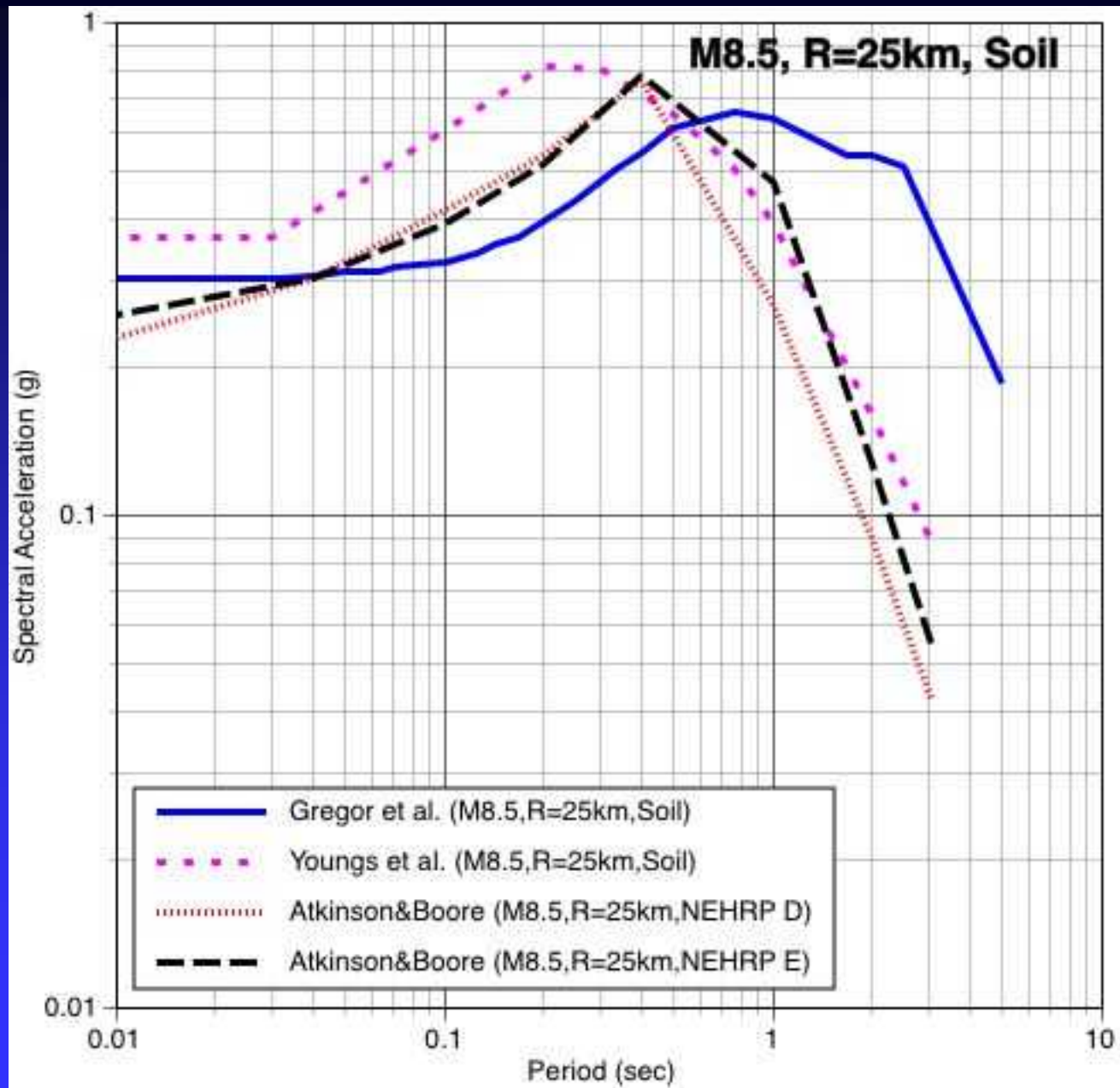


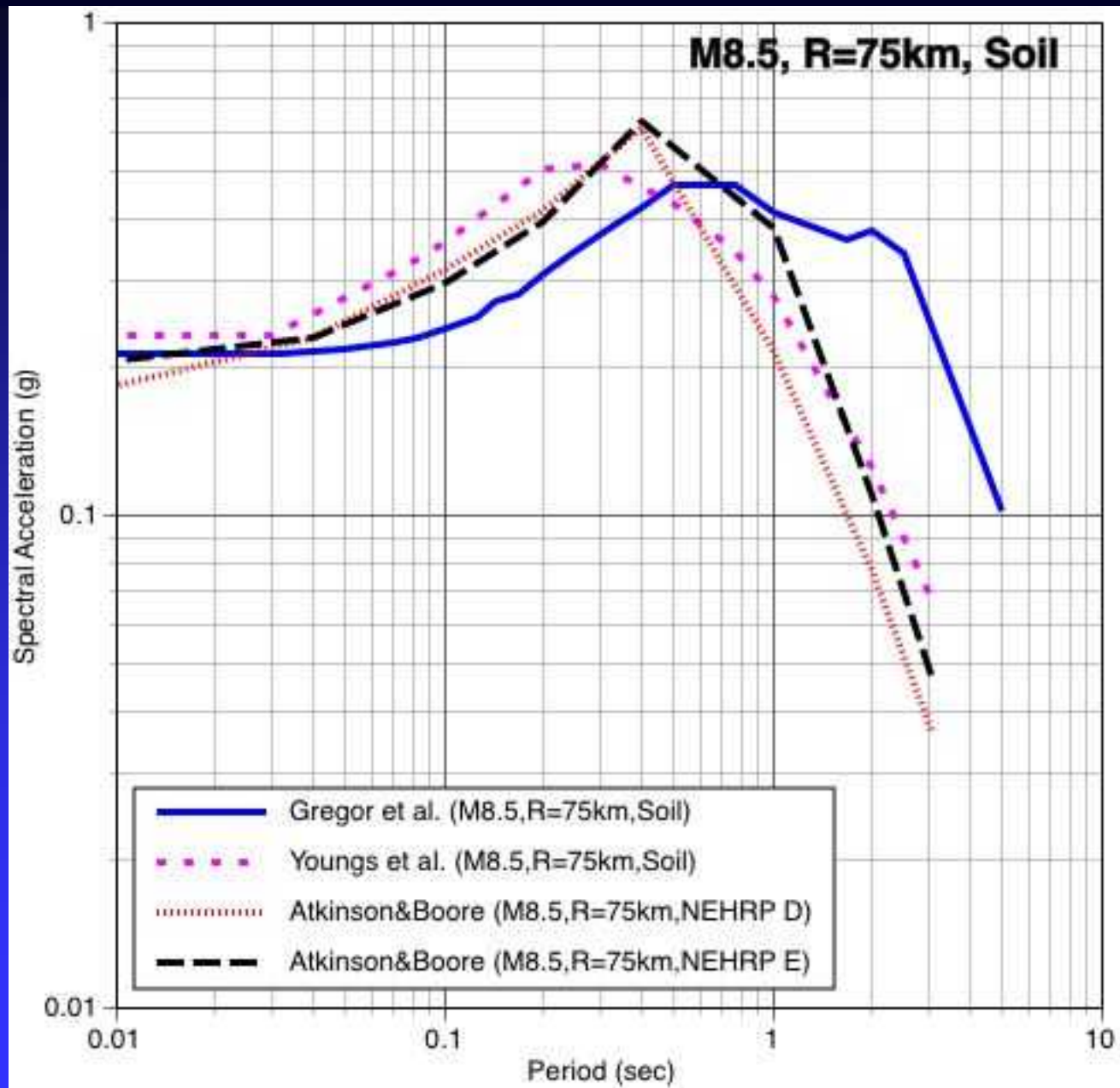


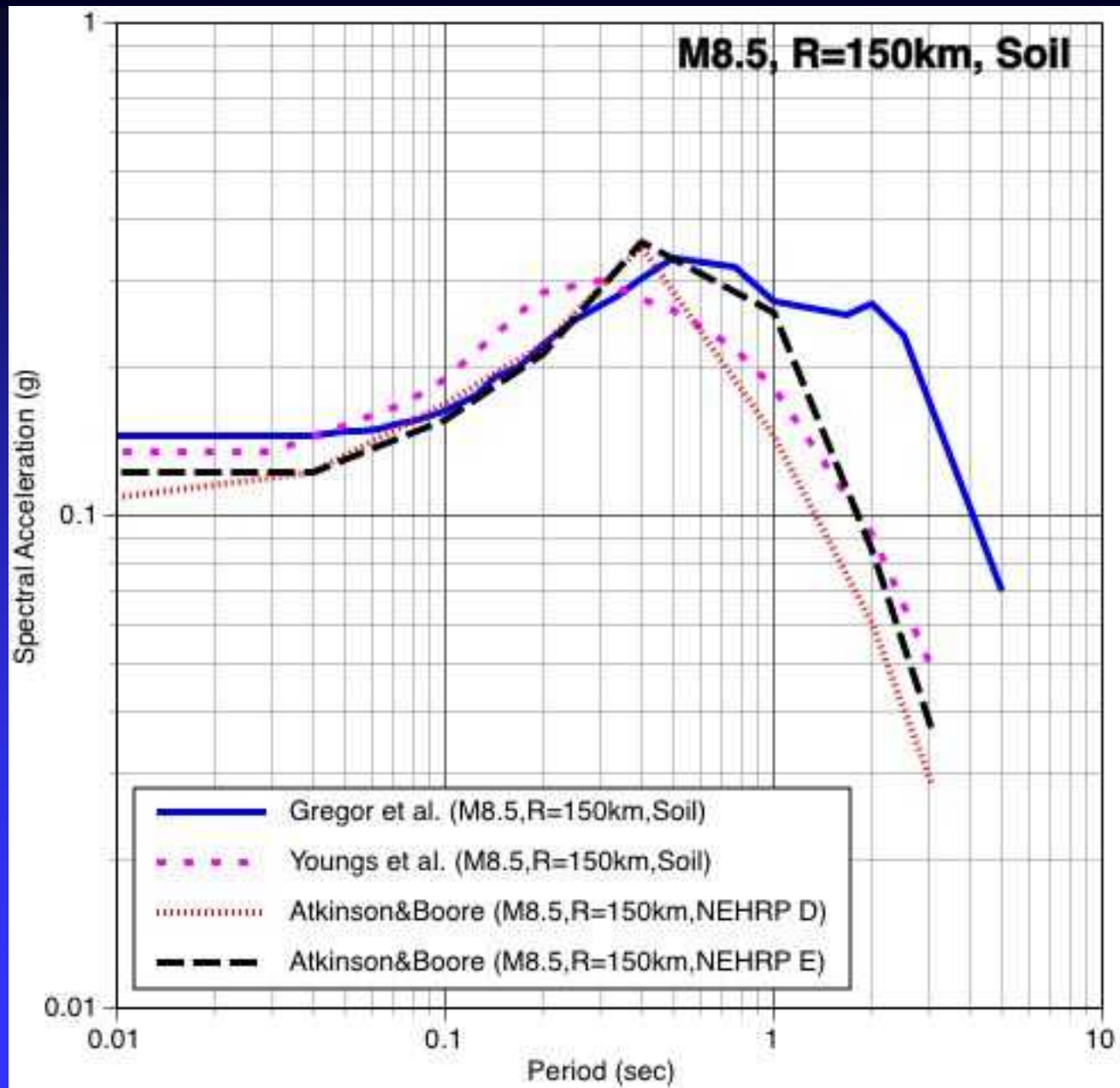


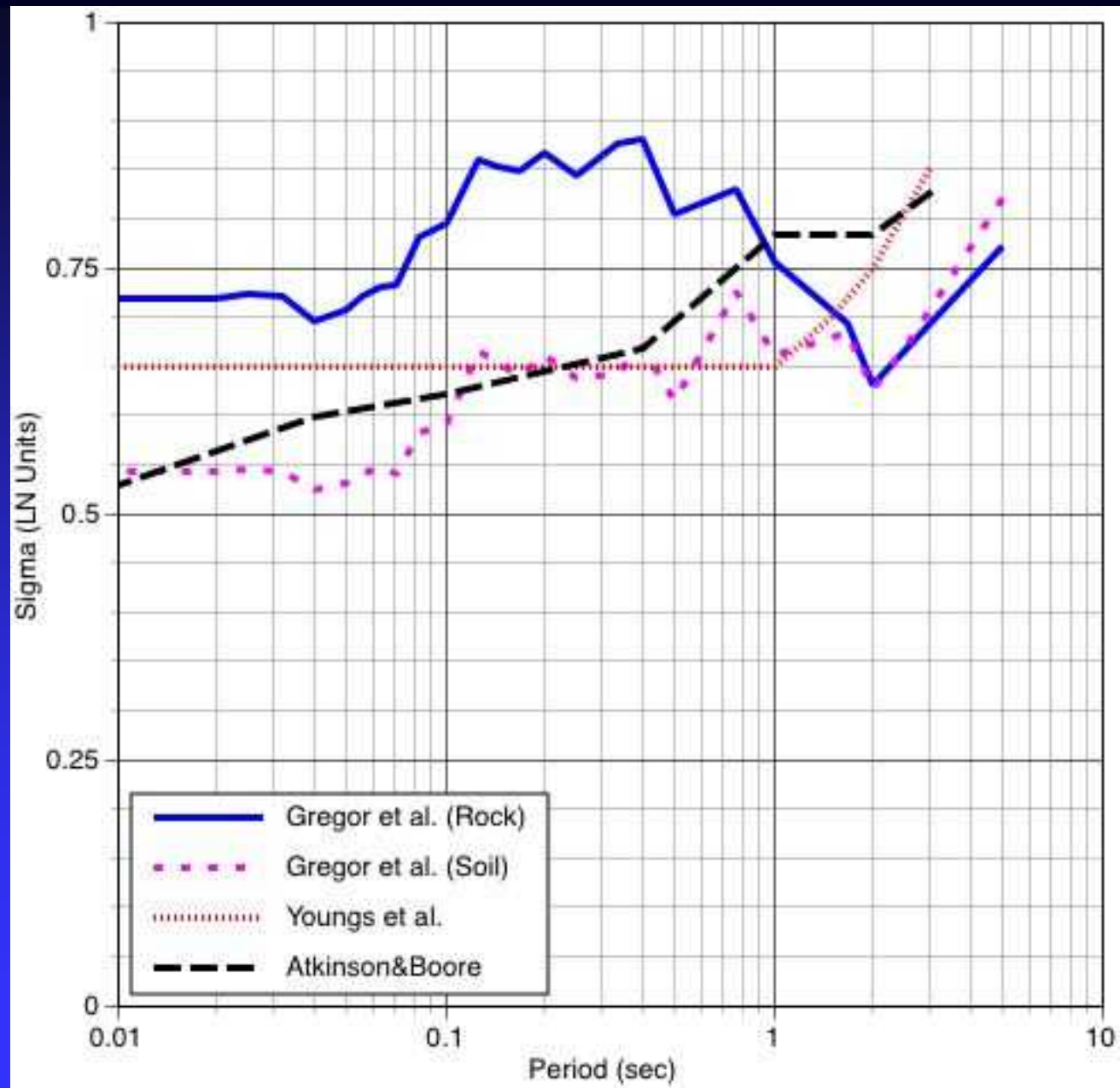








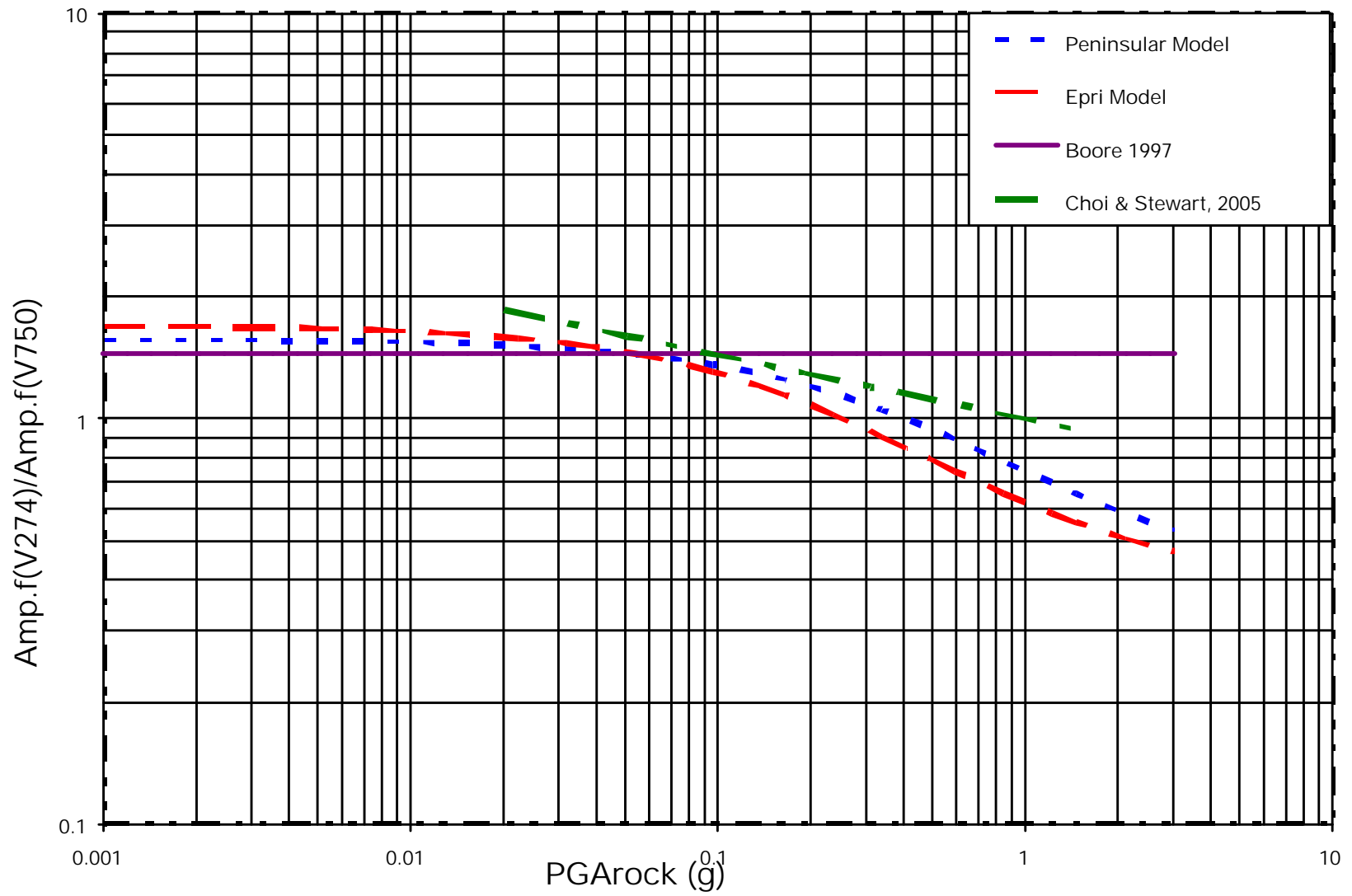




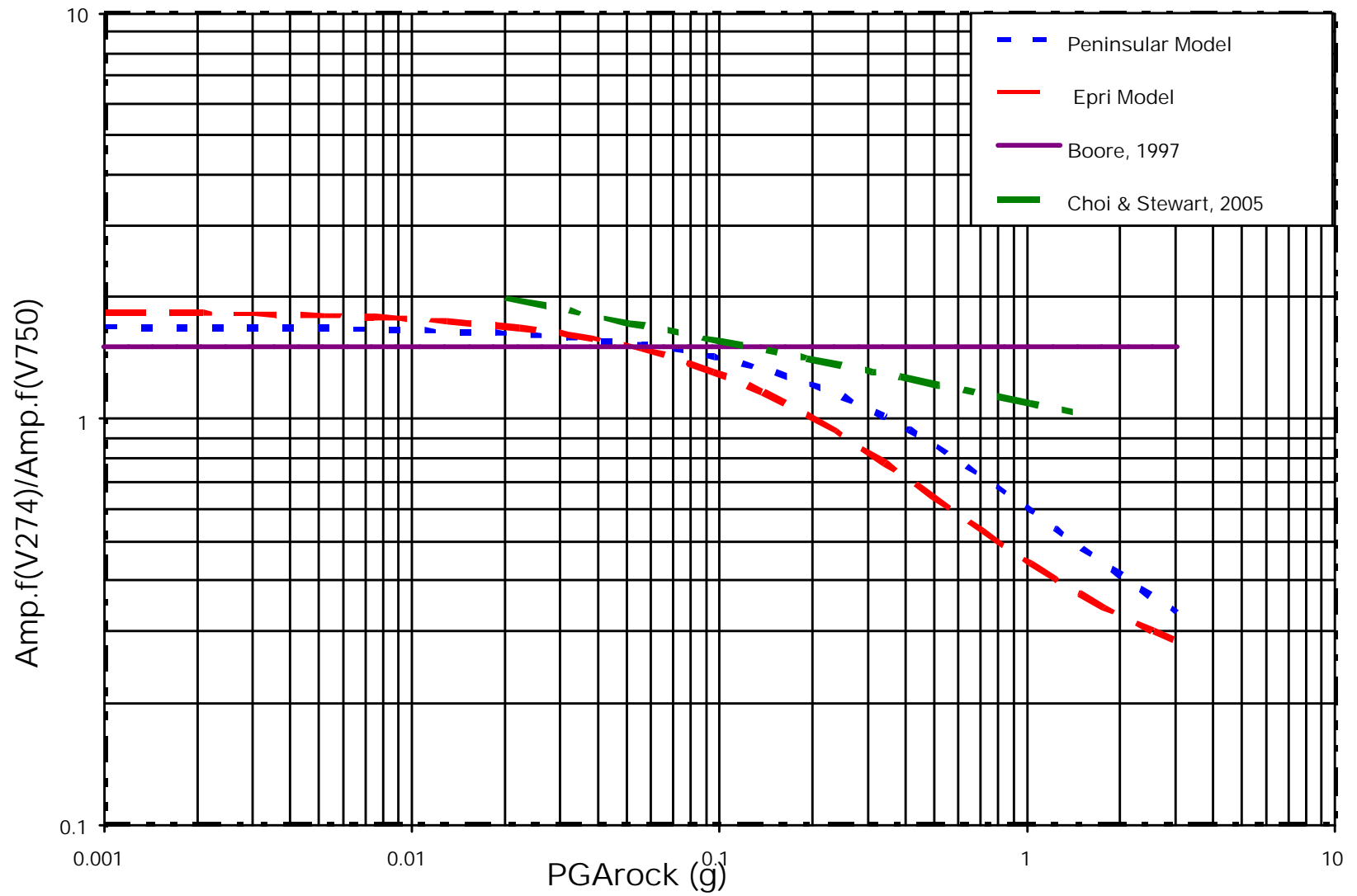
Attenuation Model Update

- Non-linear Site Response Model from PEER NGA (Walling and Abrahamson, 2006)
- Reference “Rock” $V_{s_{30m}}=1,100$ m/sec
- $V_{s_{30m}}$ range: 270 - 2,830 m/sec
- Depth range: 30 - 1,000 feet
- EPRI and Penisular Soil Curves
- Input Rock PGA range: 0.01 - 1.5 g
