Vision Statement

To protect the cultural and natural resources at Whitman Mission National Historic Site utilizing sustainable and environmentally sensitive practices in such a way that the resources will be accessible, available, and relevant to a diverse public both today and for future generations. This will be accomplished by employment of innovative partnerships, incorporating appropriate technologies (old and new), and evaluating past practices, making adjustment/corrections as necessary to protect resources.

This vision is rooted in, and grows from, the Organic Act of the National Park Service and the park's legislated mandate found in the Act of Congress (H.R. 7736, Public No. 840) on June 29, 1936. Public Law 80-543, passed in 1968, expanded the purpose of Whitman Mission NHS to include "westward expansion" through the creation of the National Trail System Act and specifically recognized Whitman Mission NHS as a site on the Oregon Trail.

- X Provide inspiring, safe, and accessible places for people to enjoy the standard to which all other park systems aspire.

Provide a safe visitor experience.

Develop and maintain electronic files so that remote users can access park resources.

- X Improve the condition of park resources and assets.
 - Restore native habitats by controlling invasive species and reintroducing key plant and animal species.

Continue the long term project to reestablish the native habitat for Doan Creek. This once free flowing stream was completely diverted for agricultural purposes prior to the park being established. Native species, both plant and animal, were lost to agricultural uses. This project reestablished the original water course and requires an active long term management to reestablish native grasses and forbs to displace the exotic varieties that invaded during the agricultural use.

Maintain park visitor use facilities in top condition.

Conduct energetic Ranger lead, on-site visitor use programs that conveys the purpose and significance of Whitman Mission as both a cultural and natural resource. Maintain curriculum based off-site programs and workbooks that relate to primary school children such as the Archeological Week at a local middle school and the salmon egg hatching at the local Children's Museum. Maintain intern programs with local colleges to provide real world experience in the conservation field.

Demonstrate and inspire leadership and innovations in environmental stewardship and green practices. Develop an exhibit that details environmental saves of the grid tied photovoltaic system to be installed on the visitor center roof. Management team members will conduct educational/informational tours of the grid tied system installed on the maintenance facility for local government staff as well as contractors and interested individuals and incorporate Environmental Management System philosophy into management based programs with other professionals and organizations.

Utilize photovoltaic and bio-diesel for heating and vehicle fuels, advance bulb designs for office and museum lighting, and other conservation measures to reduce the carbon footprint from park operations.
