These employees provided customer liaison and sales functions in support of the production of women's hosiery and tights produced at the Concord, North Carolina location of the subject firm.

Based on these findings, the Department is amending this certification to include employees of the Concord, North Carolina facility of Shogren Hosiery Manufacturing Co., Inc. working out of the above mentioned locations.

The intent of the Department's certification is to include all workers of

Shogren Hosiery Manufacturing Co., Inc., Concord, North Carolina who were adversely affected by increased imports.
