

Industrial Security Facility Clearance Survey Data—3,522 hours.

*Needs and Uses:* The conduct of an Industrial Security Review and/or Industrial Security Facility Security Survey assists in determining whether a contractor is eligible to establish its facility security clearance and/or retain its participation in the National Industrial Security Program (NISP). It is also the basis for verifying whether contractors are appropriately implementing NISP security requirements. These requirements are necessary in order to preserve and maintain the security of the United States through establishing standards to prevent the improper disclosure of classified information.

In accordance with Department of Defense (DoD), 5220.22-R, "Industrial Security Regulation," Defense Security Service is required to maintain a record of the results of surveys and security reviews. Documentation for each survey and/or security review will be compiled addressing areas applicable to the contractor's security program. Portions of the data collected will be stored in databases. All data collected will be handled and marked, "For Official Use Only."

*Affected Public:* Business or other for-profit; Not-for-profit institutions.

*Frequency:* On Occasion.

*Respondent's Obligation:* Required to obtain or retain benefits.

## **POLICY JUSTIFICATION**

### **Korea – AIM-9X Sidewinder Missiles**

**The Government of Korea has requested a possible sale of 102 AIM-9X Sidewinder Missiles; Organizational and Intermediate-Level Maintenance AIM-9X spares; 26 Section-Level Shipping containers; Organizational and Intermediate-Level training; and AIM-9X missile and support equipment; and publications. The estimated cost is \$55 million.**

**The proposed sale will enhance South Korea's defensive capabilities and increase interoperability with United States (U.S.) and multi-national forces supporting coalition operations. The country already has these weapon systems in its inventory, and will have no difficulty absorbing these items.**

**The proposed sale of this equipment and support will not affect the basic military balance in the region. The sale of the Sidewinder AIM-9X missile system is being addressed in conjunction with the planned sale of additional F-15K fighter aircraft. AIM-9X procurement will significantly enhance the Korean Air Force's current air-to-air intercept capability to equal capabilities within their region of operations. Sales of the AIM-9X have recently been approved for other customers within the region.**

**The prime contractor will be Raytheon Systems Corporation, Tucson, Arizona. Although the purchaser generally requires offsets, at this time, there are no known offset agreements proposed in connection with this potential sale.**

**Implementation of this sale will not require the assignment of any additional U. S. Government personnel in-country.**

**There will be no adverse impact on U.S. defense readiness as a result of this proposed sale.**

**(vii) Sensitivity of Technology:**

**1. The AIM-9X represents a substantial increase in missile acquisition and kinematics performance over previous AIM-9 variants. The missile includes a high off bore-sight seeker, enhanced countermeasure rejection capability, low drag/high angle of attack airframe and the ability to integrate the Joint Helmet Mounted Cueing System. The software algorithms are the most sensitive portions of the AIM-9X missile. The software continues to be modified during the testing phase in order to improve its counter-countermeasures capabilities. No software source code or algorithms will be released. Sensitive and/or classified (up to Secret) elements of the AIM-9X missiles include equipment/hardware, and software, and classified portions of operational performance. Maintenance training documentation is unclassified up to and including missile sectionalization training.**

**2. The external view of the AIM-9X Sidewinder Missile is Unclassified and is not sensitive. The seeker/guidance and control section and the target detector are Confidential and contain sensitive state-of-the-art technology. Specifically, the infrared seeker sensitivity is a significant improvement over the previous AIM-9 variants. Manuals and technical documents for the AIM-9X that support the ability to integrate with aircraft sensors are classified up to Secret. Performance and operating logic of the counter-countermeasures circuits are Secret. The hardware, software, and data identified are classified to protect vulnerabilities, design and performance parameters and similar critical information.**

**3. If a technologically advanced adversary were to obtain knowledge of the specific hardware and software elements, the information could be used to develop countermeasures, which might reduce weapon systems effectiveness or could be used in the development of a system with similar or advanced capabilities.**
