Description of content: Wood packaging material imported into Korea from all countries must be treated and certified in accordance with the standards established in the International Standard for Phytosanitary Measures (ISPM) #15: Guidelines for Regulating Wood packaging Material in International Trade or according to the manner approved by the National Plant Quarantine Service of the Republic of Korea. In case of coniferous wood packaging material from USA, Canada, Mexico, Japan, China, Taiwan and Portugal, distributing countries of pine wood nematode, only heat treatment will be approved.
