This notice supercedes G/SPS/N/CAN/157/Rev.1. Canada is increasing the areas regulated in the European Union on the basis of information that the pathogen is widely present and that a number of member states have not reported surveillance information regarding the distribution of the pathogen. Canada is also reducing the areas regulated in the United States on the basis of supporting surveillance information confirming the distribution of the pathogen Phytophthora ramorum Werres.
