Requirements and Plant Quarantine Actions for the Importation of
Wood Packaging into the Territory of the Republic of Indonesia

Introduction

Wood packaging that entry into the territory of Republic of Indonesia have a potential effect as a carrier of plant pest quarantine. Regarding to the issue, Government of Indonesia consider to stipulate *Requirements and Plant Quarantine Actions for the Importation of Wood Packaging into the Territory of the Republic of Indonesia*. Implementation of this regulation to be in accordance with International Standard for Phytosanitary Measures (ISPM) # 15.

General Provision

The importation of wood packaging into the territory of the Republic of Indonesia shall comply with these following requirements:

- a. through the designated place of entry as defined by the decree
- b. be notified and presented to plant quarantine inspector at the place of entry for quarantine actions

Special Provision

Besides the general provision, the wood packaging should also comply some special provisions, those are:

- a. free from plant quarantine pest
- b. debarked and soil free
- c. have been treated and marked
- d. for packaging carried by container should be accompanied by packing declaration from country of origin

the treatment and marking should be conducted by an accredited institution from country of origin.

TREATMENTS AND MARKING ASSOCIATED WITH WOOD PACKAGING MATERIAL

A. Treatments

1. Heat Treatment (HT) :

Wood Packaging Material should be heated in accordance in specific time temperatur schedule that achieves a minimum wood core temperature of 56⁰ C for a minimum of 30 minutes.

Kiln Drying (KD) and *Chemical Pressure Impregnation* (CPI) may be considered HT treatments to the extent that these meet the HT specifications.

2. Fumigation :

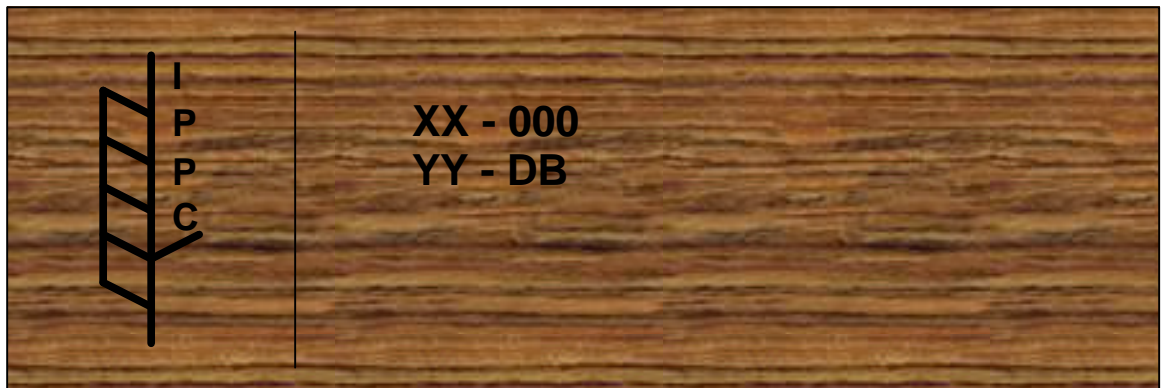
The minimum standard for methyl bromide (CH₃Br) fumigation treatment for wood packaging material is as follow:

Temperature	Dosage Rate (gr/m ³)	Minimum concentration (gr/m ³) at (CT)			
		2 hours	4 hours	12 hours	24 hours
21 ⁰ C	48	36	31	28	24
16 ⁰ C	56	42	36	32	28
10 ⁰ C	64	48	42	36	32

Dosage standard : 48 gram/m³/minimum temperature 21⁰C / 24 hour.

The minimum temperature should not be less than 10⁰C and the minimum exposure time should be 24 hours.
