<b>5. Title, language and number of pages of the notified document:</b> Regulations Governing Wood Packaging Material in International Trade (15 pages, in Spanish).
<b>6. Description of content:</b> These Regulations establish the measures to be applied by the government of Costa Rica to reduce the risk of pest spread, pursuant to International Standard for Phytosanitary Measures (ISPM) No. 15 "Guidelines for Regulating Wood Packaging Material in International Trade". The Regulations apply to coniferous and non-coniferous raw wood packaging material that may serve as a pathway for plant pests posing a threat mainly to living trees. The Regulations cover wood packaging material such as pallets, dunnage, crating, packing blocks, drums, cases, load boards, pallet collars and skids. Wood packaging made wholly of wood-based products is exempt.
