5.	<b>Title, language and number of pages of the notified document:</b> Import Health Standard Wood Packaging Material from all countries (available in English, 8 pages).
6.	<b>Description of content:</b> Wood packaging material is defined as wood or wood products (excluding paper products) used in material supporting, protecting or carrying a commodity. Wood packaging material includes items such as dunnage, crates, fillets, spacers, pallets, drums, reels, and gluts. Although exempt from ISPM 15, peeler cores are regulated by New Zealand MAF under this standard when they are used for wood packaging.
	The most important revision is that, upon implementation of this standard, expected 1 May 2006, treatment of all wood packaging will be mandatory and untreated imported wood packaging will be treated, reshipped or destroyed. It is important to note that this requirement applies to both containerised and uncontainerised/break bulk cargo.
