- **5. Title, language and number of pages of the notified document:** Ordinance on the Protection of Plants Draft Modification of the Federal Department for Economic Affairs (Available in French, 26 pages)
- **6. Description of content:** The current provisions governing the import into Switzerland of woods and wood products are proposed to be amended. In particular, the relevant provisions of the Ordinance on Plant Protection for wood packaging material would be aligned with the provisions of the FAO International Standard for Phytosanitary Measures No 15 on *Guidelines for regulating wood packaging material in international trade*.

Other amendments are proposed as regards:

- wood originating in countries where *Bursaphelenchus xylophilus* (Steiner et Bührer) Nickle *et al.* is known to occur;
- wood originating in Russia, Kazakhstan and Turkey and other countries, excepted member States of the European Communities;
- isolated bark of conifers;
- the provisions against Cryphonectria parasitica (Murrill.) Barr; and
- changes in the tariff and statistical nomenclature and the Customs Tariff.

These amended provisions are of interest for countries exporting the relevant wood or wood products to Switzerland.
